SESSION OF CITY COUNCIL

Retired Policeman Reinstated as Formerly Agreed Upon—Bids for City Printing.

BUSINESS IN DISTRICT COURT

Weber County Affairs—Wholesale Poisoning of Valuable Dogs in Ogden—Wedding Permits.

Ogden, Nov. 24.—Jerry F. Kelliher, one of the policemen who was removed from the force last spring when the city started to cut down its expenses, was reinstated last evening at the session of the city council. The appointment was made upon recommendation of Chief of Police Browning, who did so to fill the vacancy caused by the resignation of Fred Tout. In connection with the appointment the chief of police called the council's attention to a resolution passed by the council some months ago that in the event of there being a vacancy to fill that the three officers who were removed would be given the first opportunity. The appointment was unanimously confirmed by the council.

Some little discussion arose when the report of the special committee on printing submitted its reports together with bids from the two steel printers. One of the bids from the Standard was more in the form of an open letter and was returned to the committee to secure bids, though the prices were much lower than those submitted by the Journal. Before returning to the com-

mitted its report on the printing, there were several lively tiffs between the various councilmen as to the distribution of the city's printing.

A resolution was passed providing for the erection of a building on the city hall square which will be used as a work shop for the repair work connected with the city water line which will be taken over by the city on the first of the year.

DISTRICT COURT BUSINESS.

In the district court this morning before Judge Howell the case of the State of Utah against A. M. Terry, charged with mayhem, was called for trial. This case which has been continued a number of times on account of the absence from the city of John Cullen, the state's star witness, who, it is alleged, had his right ear bitten off by Terry. Cullen is employed as a porter at the Southern Pacific in Nevada and the trial has been postponed a number of times, as he was unable to be present.

William Douglas, the negro who is charged with a statutory offense, was arraigned and entered a plea of not guilty. The complaining witness in the case is a small white girl.

John J. McGuire and George Adams, charged with robbery, were arraigned and entered pleas of not guilty. The date of their trial will be set later. A decree of divorce was granted Grace Reed from Cecil Reed upon the grounds of non-support. The plaintiff was also given \$50 attorney's fees and costs.

Judgment was rendered yesterday afternoon in the district court in the case of Sidney C. Craven, plaintiff, against the Hoover Plow company in the sum of \$428.50.

The Ogden Savings bank has brought suit in the district court against Adam L. Peterson and others of Huntsville to recover \$2,999 alleged to be due upon a promissory note secured by a mortgage upon certain property in Huntsville.

At the session of the board of county commissioners yesterday afternoon a petition from Job Barnes and 32 others, asking for the opening of a road west of the city limits and between Seventeenth street and Weber river. The petition was taken under advisement.

County Surveyor Craven submitted a report upon the work done at Black Rock in Ogden canyon in the matter of the construction of a retaining wall. The report showed that the work had cost the county \$831, which was a saving of \$369 over the bids as sub-

mitted to the county for the construction of the same by contract.

WHOLESALE DOG KILLING.

The police department has had its attention called during the past few days to a number of cases of the wholesale poisoning of dogs in various parts of the city. In most every instance the dogs are those upon which the tax has been paid and are of great value to the owners. The authorities have but little clue as to the perpetrators of the heinous plot, but it is thought that before the week passes they will be able to locate the guilty ones who will be vigorously prosecuted.

ENTERED BY BURGLARS.

Workingmen's Store Robbed—Paving Contract Awarded—Deaths Record.

Murray, Nov. 24.—The Workingmen's store, situated corner of State and Leventhal streets, in south Murray, was burglarized some time Sunday night and about \$100 worth of goods taken, consisting of shoes, gloves, etc. Entrance had been gained by cutting through the door. Tools for this work were taken from a blacksmith shop across the street. No trace of the robbers has yet been discovered.
