against a right of way being granted to the Saltair Railway company on South Temple street. Committee on streets.

Charles Gilmer asked for relief from payment of city taxes on the ground that property was cutside the city. Committee on claims.

Levi Axtel, deputy watermaster, reported that one horse was not sufficient for his use and asked that \$15 per month be allowed him for extra horse feed. Committee on irrigation.

David John petitioned for a lease of the sand and gravel beds. Committee

on public grounds.

John E. Billings reported that there was \$7.50 due him for a horse taken up and sold by the keeper of the pound while he was absent from the city. Committee on claims.

D. A. Nelson asked for a transfer of unexpired license to C. M. Peterson.

Committee on license.

C. W. Higgins and others petitioned for an electric light at the corner of Fourth North and First West streets.

Committee on improvements.

Gustave H. Backman and thirteen others protested against the granting of a franchise for a broad gauge railroad track to the Salt Lake & Los Angeles railway company on South Temple street. Committee on streets.

E. A. Anderson protested against

E. A. Anderson protested against the extension of the franchises of the Salt Lake City Gas company, or the Salt Lake Power, Light and Heating company, to the Salt Lake and Ogden Gas and Electric Light company, on the grounds that he owned stock in both companies and knew nothing of an assignment to the Salt Lake and Ogden company as claimed in the resolution asked for at the last meeting. Laid over to come up under the head of miscellaneous business.

The Mayor announced the appointment of J. M. Garey and John Humple as policemen and asked that his action be confirmed. Committee on police.

The superintendent of waterworks sent in a communication with reference to the need of a new wagon in his department, which will cost \$80. Committee on water works.

TWELFTH EAST STREET GRADE.

The city engineer reported the cost of bringing the intersection of Second South and Twelfth East streets to the permanent grade. The estimate was as follows:

This estimate does not include the cost of masonary for railroad crossings, which would co-t about \$20,000, and which should be paid by the railroads. Referred to the committee on streets.

Superintendent of Sewers Shelton called attention to the request for an extension of sewers on West Temple street from its present terminus near the center of the block, between North and South Temple streets, the tax having been paid. Committee on sewers with power to act.

BOULEVARD ROUTE.

A communication from a committee of the businessMen's Association, signed by George Y. Wallace, A. G. Bas, H. C. Goodspeed, Wm. Burke, Le Grande Young and E. F. Colburn, was submitted, outlining the route of the proposed boulevard, which is as follows:

Commencing at the accepted center of

the city, the southeast corner of the Temple block, thence northwesterly, passing the Descret University square, to the Warm Springs park, thence in a south-easterly direction to a point near the northwest corner of the Capitol grounds to a point near City creek canyon, thence northeasterly, following the course canvon. of the watermains connecting Capitol Hill reservoir with Capitol Hill tank on the west side of City Creek canyou; a distance of about 5,000 feet, to distance of about 5,000 feet, to Capitol Hill tank; the tank is about 45 feet higher than the reservoir. Then follow down the road at the bottem of the canvon to a brick tank house, thence southeasterly along the east side of City Creek canyon to the tower built by Mr. Anderson, the same being at or near the intersection of A and Seventh streets—the tower is but twenty-one feet higher than the brick stank house thence east to the western boundary of the city cemetery, thence south and east to the Fort Douglas military reservation, thence southeasterly to and through Fort Douglas, thence southwesterly by way of Mount Olivet cemetery, to or near the intersection of Sixth South and Thirteenth East streets, thence west passing the Exposition square, thence south to Liberty park; returning pass the county and city building to the center of the

Committee on streets.

ANOTHER VETO SET ASIDE.

The Mayor's veto of the appropriation bill, to which reference was made in the NEWS of Tuesday, was made void by a vote of 11 to 2 and one excused.

MISCELLANEOUS.

The committee on streets and sewers reported tavorably upon the ordinance granting a franchise to H. M. Bacon et al. for laying water pipes on certain streets in the city, for the purpose of building a sanitarium. Adopted.

The committee on streets reported favorably upon the petition to grant an extension of franchise to the Salt Lake and Ogden Gas and Electric company, and recommended that the matter be referred to the council for agreement as to details, to be considered in Friday evening. Adopted.

The committee on improvements

The committee on improvements reported favorably upon the petition of certain parties for an electric light at the intersection of North and Third streets and Twelfth East and South Temple streets. Adopted.

The committee on improvements reported favorably upon the petition for an electric light on first South and Eighth West streets. Adopted

Eighth West streets. Adopted.

The committee on finance recommended the approval of Samuel Gilleazzi's bond as deputy dog tax collector, in the sum of \$500. Adopted.

The committee on claims reported adversely upon the bill of Professor Hirsching for services in attending court at Ogden as a witness in the case of Allred vs. Salt Lake City, upon the ground that the professor had been paid \$216, and they thought that was sufficient. Adopted.

The committee on sewerage reported favorably upon the petition of T. F. Mulloy et al. for an extension of main sewer on Fifth South street from Second East to Sixth East for the purpose of furnishing an outlet, for the laterals of the petitioners. Adopted.

The Proceedings.

The committee on streets reported favorably upon the extension of the franchise of the Salt Lake and Ogden Gas and Electric Light company.

A lengthy discussion then ensued as to whether or not the ordinance submitted in connection with the report had been read in full or by title at a

previous meeting.

Folland said he did not understand why so much haste was manifest in the passage of the ordinance. It was an important measure and should be given careful consideration. When members pressed the passage of a measure as they were endeavoring to do in this instance, even before the ink with which it had been written had time to get cold it looked a little suspicious. Besides there was other business which should be disposed of. Petitions had been presented to the council three or four months ago and they were constantly ignored. Business should be transacted in a business-like manner; everything should come up in its turn.

Horn cailed Mr. Folland to order saying petitions had not been ignored

as insinuated.

Folland retaliated spiritedly by saying that Wendell Benson fully four months ago had asked for a gas franchise and proferred to furnish gas at \$1.75 per 1000 cubic feet, and that Mr. Horn was well aware of it.

The president rapped order, after which the ordinance was read the first time, and by reason of certain interpolations having been made, further action was postponed until one week

from Tuesday next.
