PICTURES AND EVES.

How to Adjust the Lenses to Properly Observe the Focuser.

The observer, in order to see a picture to the best advantage, must adjust his vision to that of the artist who produced it. Most of us do this instinctively. You only do so when the point of view from which to observe a picture, but we do not when the picture is taken from a point of view which is not the artist's own eye, and that the picture thus apparently is inverted.

A most useful appliance for viewing pictures is the so-called stereoscope. This is merely a slit one or two millimeters in width in a card or thin plate of wood or metal. This device is held before the eyes, and the two pictures are viewed through it. The effect is that the two pictures are brought together, producing thus a stereoscopic effect, such as the artist had produced in his own eye, and that the picture thus apparently is inverted.
