After a lingering illness, at his residence in St. George, Utah, September 21, 1880, JOHN ORSON ANGUS. Deceased was born 27th November, 1812, in Glasgow, Scotland; was first baptized in October, 1840. In 1842 he left England with his aged father, who was over 70 years old, for Nauvoo, Ill. He was sent

on a mission to canvass Kentucky for the Prophet Joseph Smith's candidacy for the Presidency of the United States in 1844. He was ordained a member of the 27th Quorum of Seventies in 1845. From the time he left Nauvoo, until his arrival in Salt Lake Valley in 1847, he was always on duty. In 1850 he was called upon a mission to England, which he faithfully filled and returned to Salt Lake City, after an absence of four years and six months. He was called to Dixie in 1861. Was appointed a member of the High Council in St. George, 14th May, 1864, and was still a member when he died. He was time-keeper on the St. George Temple Block a number of years, and door-keeper in the Temple from the time it was finished and dedicated until its close for renovating 25th June, 1880. He bore a strong and powerful testimony of the truth of the Latter-day work, and said, "I know that my Redeemer liveth." He suffered much in his affliction, but passed away in peace, to await the resurrection of the just.—[CGA.]

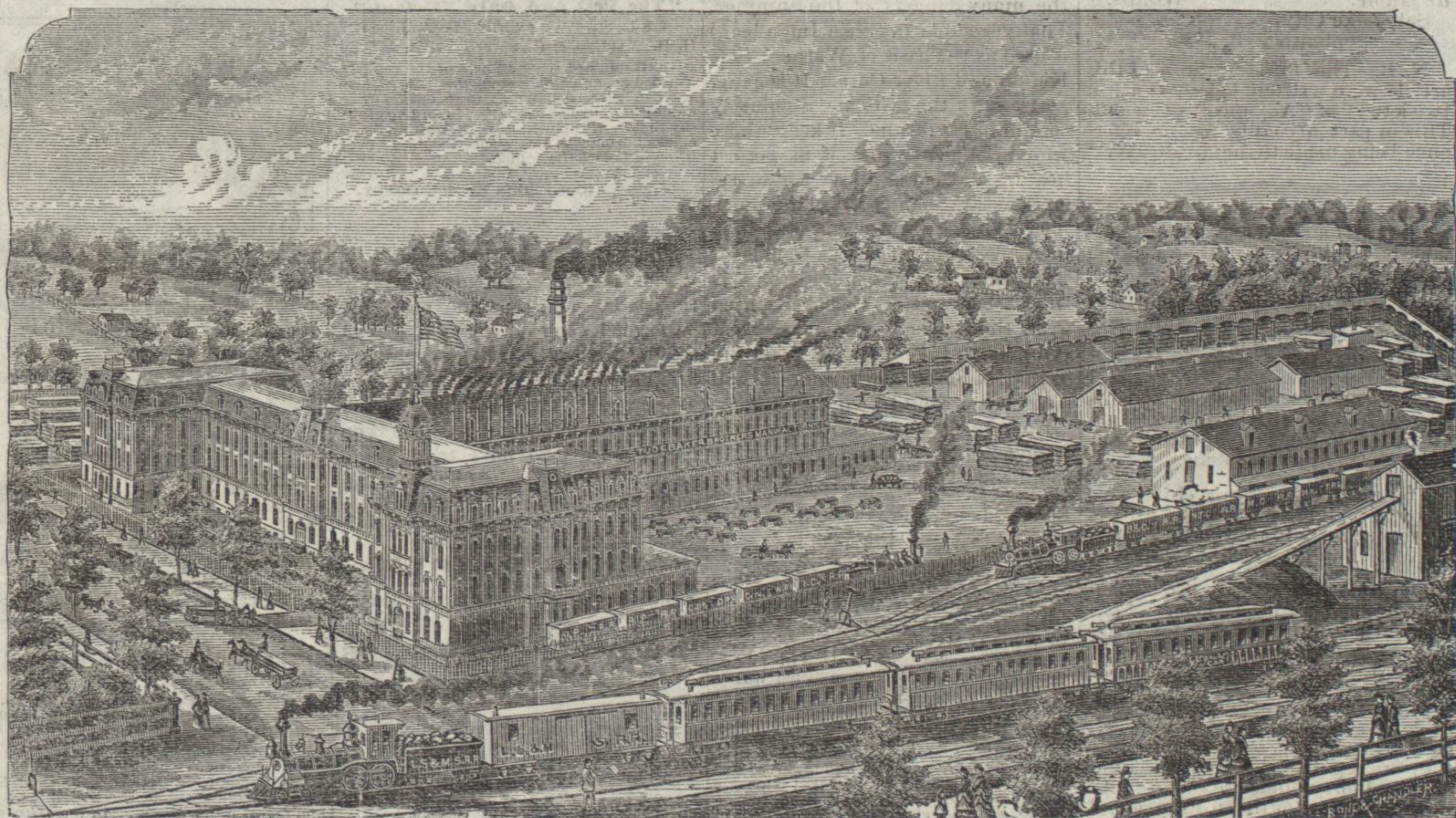
