THE SELECTMAN DIFFICULTY.

A Candidate for the Reform School—Short Orders Made by Judge Zane Today.

Chief Justice Zane held court as usual today.

The first case on trial was that of Edward G. Hooper and Elizabeth Hooper (for whom Laney & Stewart appear); vs. the Salt Lake City railroad company, represented by Rawlins & Critchlow.

It was an action for damages for \$10,000 and costs, on account of personal injuries sustained by the female plaintiff on September 19th, 1892.

On the date named Mrs. Hooper was a passenger in one of the company's cars running from Eighth Street to the Salt Lake City station. She was a widow, and was traveling alone. On the date in question she was driving her car at a rate of speed of 20 miles per hour. The company's cars were running at a rate of 15 miles per hour.

At the time of the accident the car in which she was traveling was overtaken by another car, and the two cars were in collision.

It was impossible for the management to get full information which is desired by the state of the condition of these sufferers, for they fear their punishment would be too severe. It is to be regretted that the court failed to give the plaintiff a chance to explain her case, for she did not care if she had to go to jail.
