HOW A PRISONER ESCAPED.

Alice and Jessie Gill; Peter Elliot; Eliza, Elizabeth and Marg. Camp-bell; Francis Allen; Sarah, Jessie, James and Margaret Gray; Janet. Thomas B. Love, of Hill County, Texas, was a Confederate soldier under Brig. Gen. Lyons, and while the command was on the march in Western Kentucky, in the winter of 1865, a Federal, who turned out to be a notorious spy and bushwacker, was captured.
