PROGRAM FOR PORTLAND MEETS.

Jesse M. Smith of Utah to Speak On "Forest Reserves and Sheep Grazing."

GOV. WEELS ON THE PROGRAM.

Latter Will Address Live Stock Association While Former Will Talk to Wool Growers of Country.

Following is the program of the thirty-ninth annual meeting at Portland of the National Wool Growers' association, which convenes in Baker theater Monday, Jan. 11, and which will be attended by a large number of Utah people.

Monday—Prayer, Rev. E. S. Muckley, pastor First Christian church. Annual address of the president, Hon. Francis E. Warren. Annual report of the secretary, Hon. Mortimer Levering. Annual report of the treasurer, Mr. A. J. Knollin. Appointment of committees. Introduction and reference of resolutions. Consideration and adoption of new constitution and by-laws. Reports of committees. The forest reserves and the range sheep industry. Discussion will be inaugurated by brief addresses explaining present existing conditions in various states and territories by the following:

"The Public Land Laws and Needed Amendments Thereof," Hon. F. H. Nowell, chief hydrographer of the United States geological survey, and Hon. Gifford Pinchot, members of the special commission appointed by the president of the United States to investigate and report on this subject, will address the convention and the subject will be open to general discussion and for the consideration and action on resolutions.

"Mutton Sheep as Viewed from the Leading Markets"—Chicago—Mr. A. C. Halliwell, Kansas City—Mr. W. H. Weeks, St. Joseph—Mr. M. B. Irwin, Omaha—Mr. S. D. Parkhurst. Unfinished business and general resolutions. Selection of next place of meeting.

LIVESTOCK MEETING. Secy. C. F. Martin of the National Livestock association has sent out bulletin 47, giving in detail the program of the Portland convention which opens on the 12th inst. The questions of forest reserves, arid lands, packinghouse combines and transportation are matters which demand immediate and decisive action by the stockgrowers of this country and will be discussed. The necessity of some immediate action on the land and forest reserve question is recognized by President Roosevelt, who has authorized Hon. Gifford Pinchot, chief forester of United States, and Hon. F. H. Nowell, chief engineer of the department of geological survey, members of the recently appointed land commission, to attend this meeting for the purpose of the discussion on Thursday, the 14th of January, when Hon. Heber M. Wells of Utah, Dr. J. E. Stubbs of Nevada, and Hon. Thomas Haley of Oregon will represent the stockmen in the debate, while Messrs. Pinchot and Nowell will represent the government.

CHINESE IN THREE STATES.

Utah, Wyoming and Nevada Have A Total of 1,143. Almost Entirely Male.

FORMER'S PROPORTION IS 156.

Difficulties Encountered by Inspector Paine in Enforcing the Immigration Laws.

Chinese Inspector A. W. Paine for the district comprising Utah, Wyoming and Nevada, has compiled an enumeration of the Chinese now residing in these three states, showing a total of 1,143, almost entirely male. Mr. Paine has charge of all Chinese matters under the exclusion law, and also the enforcement of the immigration laws, and says there has been considerable trouble with Chinamen in the loss of their certificates; also in the fact that when one dies the chances are that his certificate is given to some live Chinaman who has either lost his or been smuggled into the country. The Chinese do not report deaths, so that the inspector must depend upon local authorities and the newspapers for such information. Sometimes it is necessary to make expensive trips just to secure the registration of one or two certificates, though at other times this can be done by correspondence.

Chinese desiring to leave this country and return should make application in person to Mr. Paine for a return certificate, and such as have lost their certificates by fire or other unavoidable causes should make application to the commissioner-general of immigration, Washington, D. C., through the office at Salt Lake, for a duplicate certificate of residence; a circular as to the form to use will be mailed on application. The office of Inspector Paine is at 415 Deseret News building annex, Salt Lake City, Utah.

In Salt Lake City there are also nine Chinese boys and five girls. In Wyoming there are 358 Chinese men and three women, with one boy and one girl so all the way round. Rock Springs has the greatest number, 185; Evanston has 36, and Cheyenne, 25. Nevada has 1,052 Chinese men and 62 women, with 19 boys and 10 girls. Carson City has the greatest number, 109; Reno and Winnemucca have 90 each, Elko has 50, and Hawthorne 52.

JOBBER'S ASK SQUARE DEAL

Claim Discrimination Against Utah in Existing Freight Rates.

There was a large attendance of Salt Lake and Ogden jobbers and shippers at the Commercial club meeting last night, to work for better freight rates

for Utah and less discrimination in favor of adjoining commonwealths. The railroad companies were severely criticised, and there were some denunciations. President E. P. Holmes presided, and called attention to the fact that every road running into this city from the east had adopted a discriminating schedule of rates which, if continued, would work great injury to the jobbing and shipping interests of both Salt Lake and Ogden, Cal. Holmes asked the meeting to empower the governors of the Commercial club to appoint a committee to make a thorough investigation and give the committee money with which to hire experts. The following resolution was finally adopted:

"In view of the fact that there is now in effect a schedule of freight rates in Utah, by reason of which the jobbers and shippers of the state are practically barred from operation in their legitimate markets, we, the jobbers and shippers of the cities of Salt Lake and Ogden, urgently request the board of governors of the Commercial club to use all means in their power to secure an early and equitable adjustment of the discriminations complained of, and pledge them our loyal support in their efforts to accomplish this purpose."

The following committee was appointed to work with the board of governors: S. H. Love, Z. C. M. I.; W. P. Kiser, manager of the Henry Wagner Brewing company; W. S. McCarthy, traffic manager of the Salt Lake Roadway company; F. J. Fabian, of the firm of Jung & Fabian; Joseph Geoghegan, commission merchant, and Joseph Seaveroff of Ogden.

The committee was instructed to secure experts and proceed at once, and it is expected that the committee will be able to make a full report in two months.

AFTER A LONG ILLNESS. James Lozier Dies Alone In His Room On Second South Street.

The dead body of James Lozier, a laborer, was found about 5:30 last evening in his room at 42 East Second South street. An investigation by Coroner Clark revealed the fact that the man had come to his death from natural causes.
