THE FULLER WATER RIGHT.

· Reporting on the petition of Wm.

Fuller asking that the watermaster be lustructed not to interfere with his right to take fifteen acres of water from the Decker ditch, that official set forth that about fifteen years ago Paul A. Elkins claimed and used three acres of water; that later on he used more; that James Johnson, a former watermaster, is unable to say how much water said Elkins used; that the Decker ditch is entitled to only thirtythree acres of water altogether; that as watermaster he had no jurisdiction over the said ditch. CONTRACT FOR PAVING RICHARDS

STREET.

The same body reported that it had entered into a contract with the Wasatch Asphaltum company of this city for paving Richards Street; that the contractor had executed a bon! with G. F. and H. L. A. Culmer as sureties to guarantee the proper performance of the work, Committee on municipal laws.

The same official reported that in his opinion the city was under no legal opinion the city was under no legal obligation to erect retaining walls on State street for W. C. Godbe and John Green, but in the case of John R. Park the city was liable, but not beyond the cost of removing the soil from Park's premises. Laid on the table until the next meeting.

THE PIONEER LIBRARY.

The city attorney sent in an opinion in which he announced that the city could legally appropriate \$1000 a year for the support of that institution.
