CONGRESSIONAL.

SENATE.

WASHINGTON, 25.—The bill to amend the judicial powers and functions of consuls was passed.

Senator submitted a resolution instructing the committee on judiciary to inquire into the expediency of limiting the jurisdiction of the United States courts so as to relieve the pressure of business thereon. Agreed to.

Ordered, from the committee on public lands, reported favorably the House bill to provide for the publication of notices of contract under the homestead, pre-emption and tree culture acts. Passed.

At the expiration of the morning business consideration was resumed of the bill providing a permanent form of government for the District of Columbia and after debate the sixth section providing for the election of a delegate to House of Representatives was struck out by a vote of yeas 40, nays 3. The House provided for the election of a council, and the Senate committee amended the section so as to elect a delegate to Congress instead of a council. The section having been struck out there will be no election in the district.

An amendment that no payment shall cost more than \$2 per square yard was adopted, and consideration was required to file adequate bonds.

The sections abolishing the board of police commissioners and the board of school trustees and transferring their powers to the commissioners of the district were agreed to also the section abolishing the sinking fund commissioners and transferring their powers to the treasurer of the United States.
