the Advance assigns as an agent in the production of crime is the newspaper. This may sound strange, but the charge, nevertheless, is not entirely groundless. The average editor ridicules the temperance movement and religious reform more than he does the saloon. He hurls his coarse jokes at the advocates of morality.

The Advance says that newspaper editors who are helping the davil must change sides, preachers who are decrying religion must uphold it, and literary people who are sowing the world with unbelief and pollution should quit their wickedness and plant it with faith and righteousness.

UNDER FALSE PRETENSES.

PROMINENT people and several papers in Beston are being deceived by the plagiantst preacher, J. Westley Hill. His rival and whilem associate, Sam Small, has been tushed to the rear as a champion and money-gatherer for the Ogden University, and Hill comes to the front with as much assurance and mendacity though with less emartnessand originality.

We have no objection to the collection of funds in the East for the purpose of erecting a fine building in Utah for educational purposes. That meaus much capital brought Into the Territory, and employment for a number of local workmen. Nor have we anything to say against a denominational college, whether it be in the interest of the Methodist or any other religious association. But we are opposed to the obtaining of money under false pretenses, whether it be by a common confidence man or a sleek religious charlatan.

Universities, academies, schools of learning are all right for Utah. Good public buildings of any sort help to improve the appearance of our cities. But they ought not to be established at the expense of truth and through the defamation of "Mormon" citizens of this Territory. If the Methodists want the credit of building a university here, whether it is a public necessity or not, they have the right to build it and make as much noise about it as they please. But no man has the right, after the fashion of the Hills and the Smalls, to lie about the "Mormons" in order to raise the funds that are wanted to pay for the work.

tarian form of modern Christianity, certainly not to Methodism. For the purposes pretended by Small until he was retired for alleged fraud, and now set forth by the smaller wit but greater humbug, Hill, the projected establishment can have no probable effect.

The ministers and editors who are boosting Hill, and echoing his stories about "Mormon" ignorance and the good to be done among the "Mormon" people by aid of the University-when it is built, are only beloing to deceive the public and aiding in obtaining cash solely to benefit the Utah Methodists, unless it be in the way we have indicated, that is in dcing material good to the Territory.

"President" Hill, as some of them call him, is not President of the University. Sam Small was-on paper, until his defalcations were discovered Hill is simply a very common itinerant Methodist preacher, who is noted in Ogden chiefly for plagiarizing sermons and a coarse manner of attacking the "Mormons" in the pulpit, and even in that, borrowing his vituperation from

abler clerical blackguards.

If any of the Boston "Christians" think it is a good thing to help the Utah Methodists in building a university for the benefit of their sect in Ogden, and are liberal enough to make donations for the purpose, that is all right, so long as a close watch is put upon the expenditure. But this should be done on the square, and the benevolent public should not be induced to give their money on any such false pretences as lack of schools among the "Mormons," or their probable conversion to Methodism, through an institution that none of them are likely to enter and a creed which they well understand and for which they can have no possible use.

A JOURNAL entitled The Christian Cynosure contains an article, said to have been prepared by the "Home Board," whatever that title may refer to. It is headed "Facts in Mormonism," and consists of a rehash of old, stale, flat and unprofitable trash. few extracts will suffice to exhibit the nature of the anti-Christian journal. istic conglomerate. It says:

occasional attempts to make it appear that the Book of Mormon is an adaptation of Solomon Spaulding's story, in the face of the fact that the original Spaulding manuscript was discovered several years since, and is now in the archives of the Oberlin (Ohio) college. It is no more like the Book of Mormon than a molehili is like Mount Nebo. However, The Christian Cynosure Itself shows the absurdity of the fulminations of the "Home Board" which it gives to врасе. the same issue as that in which the abusive article appears is the following:

"Judge Charles S. Zane, the chief justice of the Supreme Court of Utah, has presided at the trials of all the Mormons who have been tried for polygamy. It shows well for a cause, religious or otherwise, when the principal weapons with which its opponents seek to render it odious consist of tissues of falsehood.

THE NATIONAL REPUBLICAN CONVENTION.

GENERAL J. S. CLARKSON is in Washington arranging the prelimic. aries for the National Republican Committee, which meets on Monday, November 23rd, in that city. Four claimants—Cincinnati, San Francisco, Minneapolis and Omaha, are already actively working to get the National Republican Convention next year. Chicago and New York are also said to be in the field, but formal claims have not yet been lodged with the secretary.

Personally, Mr. Clarkson reports hamself to a Mail and Express correspondent as favoring New York. That city, he says, has not had a convention in many years.
