The Strike on the C. & Q.

CHICAGO, March 28.—Everything is
quiet in the yards of the Burlington
road this morning. The officers claim
that by tomorrow the full working
force of the Chicago yards (150 switch-
men) will be secured. Thirteen switch-
engines and fifty switchmen are at
work and some headway has been
made in moving the accumulated
freight.
A dispatch from St. Joseph, Missouri,
says:
"All 'Q' switchmen, thirty-five in
number, struck here last morning, and
not a wheel is turning."
The Burlington engineers and fire-
men practically cut away from their
leaders and grievance committees to-
day and took over the road. The
reason for this action was that the
more impulsive had become im-
patient over the slow and appar-
ently unsuccessful methods of Chief
Arthur. They wanted to strike the
road and see if they could not
committees and sent them out to
work. Every road running into Chi-
cago was visited, and pledges were
obtained from all the switchmen and
engineers that under no cir-
cumstances would they strike.
Later in the day a mass meeting was
held. Delegates from all the roads
were present, and the pledges made to
the committees were repeated. To-
day the Burlington engineers and fire-
men were positive that a Burlington
car would be moved tomorrow except
on Burlington tracks. The strikers
estimated further steps in the great
struggle with the Burlington would be
taken in a day or two.

vaded by hordes of naked and star-
ving refugees from the flooded dis-
