OPPOSITION TO DAM FRANCHISE.

Commissioners Listen to Arguments Against Proposition—Nothing New Presented.

HEARINGS IN DISTRICT COURT.

Divorce, Civil and Criminal Cases Heard by Judge Howell—City and County School Affairs.

Ogden, Utah, Dec. 9.—The board of county commissioners held a special session yesterday afternoon for the purpose of giving the residents of Eden an opportunity to present their arguments against the proposition to build a dam and reservoir near the head of Ogden canyon, and to change the canyon road, leading to that settlement. Several gentlemen from Ogden valley presented their objections, which were about the same as those already given out. The gentlemen suggested that there are other sites in Ogden valley more suitable, where immense bodies of water would be stored and believed that it would be to the advantage of all concerned to select another site. Engineer Easton was present and argued along the same lines. However, it is very evident a majority of the residents of the valley favor the granting of the franchise to the Utah Light & Rail-way company. General Manager E. S. Campbell, Attorney Le Grand Young, Local Manager E. W. Wade and other representatives of the company were present and had a conference with the commissioners. It is fully expected that at the regular meeting of the county board on Monday some definite action will be taken upon the proposition, which is a very important one to the people of this county.

CIVIL AND CRIMINAL CASES.

Heard by Judge Howell in the District Court.

Ogden, Dec. 9.—Judge Howell considered a number of criminal and civil matters in the second district court yesterday afternoon. The case of Emil Larsen vs. Ludwig Larsen, charged with assault, is appealed from the municipal court, where they were found guilty, was completed and submitted to a jury, which brought in a verdict of not guilty. The young men were charged with striking their father and cutting a gash on his head and otherwise severely wounding him. Mr. Larsen has had all kinds of trouble with his family of late and his wife is now suing him for a divorce. The case of the State of Utah against William Gill, charged with assault with a deadly weapon, was called before his honor, on request of District Attorney George Halverson, the action was dismissed and the defendant released from the county jail. Gill, it is alleged, quarreled with a man named Duran, whom he stabbed in the back with a knife, but the wound was not severe, and the complainant has left the state. Ruy Varnez, charged with adultery was arraigned, and date for pleading set for next Tuesday. Ed Penner, charged on two counts, that of burglary in the first and second degree, was arraigned on the charges, and Monday next set for date for plea. In the case of Harvey G. Taylor against Ogden City, suit brought for damages for personal injuries, the defendant was overruled and judgment given 20 days in which to answer. In the case of A. G. Fell against the Union Pacific and Oregon Short Line, the plaintiff was granted permission to amend his complaint. Otto P. Meekes, a native of Germany, was granted naturalization papers.

CHRISTENSEN DIVORCE.

The divorce suit of Lulu Brown Christensen against Norman Christensen, the shoe dealer, was concluded yesterday afternoon before Judge Howell, and a decree of divorce granted the plaintiff as prayed for. She was also given custody of their little child, \$15 per month alimony for three years, \$25 attorney's fees and costs of suit. The parties to the suit are well known in Ogden.

TWO DIVORCE SUITS FILED.

Two mismatched couples are desirous of a legal separation, and have filed divorce suits in the second district court. Mary Pone has filed a suit against Charles I. Pope to secure a dissolution of the bonds of matrimony existing between them. The couple were married at Laramie, Wyoming, Feb. 23, 1896. Over a year ago, it is alleged, the defendant deserted his wife and has since refused to live with her. The other suit is brought by Daniel Vest against Gertrude Vest. This time the wife deserted the husband and her two children over six years ago. They were married Aug. 27, 1885, and have two children as issue of their marriage. Plaintiff asks for custody of the minor children, divorce and such other relief as the court may deem just. An amended complaint has been filed in the second district court by Maginlis & Corn as attorneys for Mike MacDonagh against the Union Pacific Railway company, to recover \$10,000 alleged to be due for personal injuries. The complaint alleges that April 16, 1905, the plaintiff was in the railroad yards of the defendant company, when a man who was a railroad watchman stepped up to him and spoke in a very rough manner to plaintiff, which frightened him and he commenced to run, but had only run about 25 yards when the watchman fired a shot at him, which took effect in his leg, shattering the bone and severing the tendons, causing plaintiff to be confined in a hospital for 60 days, and resulting in injuries that are permanent making it impossible for him to do hard work.

STREET RAILWAY EXTENSION.

Monday next, the extension of the streetcar service from Twenty-fifth street on Wall avenue and up to Twenty-third street to a point where the Rio Grande Western recently laid its track across the street, will be put into commission. Two cars will be placed on this line, which will extend to Twenty-fifth street and Washington avenue, and will supplant the present "shuttle" car system to the Union depot.

SCHOOL FUNDS APPORTIONED.

W. N. Patterson, superintendent of the county schools, submitted an abstract to the county treasurer yesterday showing the distributions of the county school fund. The amount apportioned is \$12,613, and the school population of the county, 6,485. Of this number, 6,236 are in Ogden City, and the amount apportioned to the city is \$9,354, a per capita of \$1.50. In Weber county, outside of Ogden City, the school population is given at \$3,259, and the amount apportioned \$3,259, a per capita of \$1.

MEETING OF SCHOOL BOARD.

At the meeting of the city board of education last night Judge Patton appeared in connection with the establishment of a detention home for boys in Ogden. He urged the board to use the building at the rear of the High school for that purpose, but no definite action was taken. The finance committee reported cash on hand to the amount of \$12,839. The sanitary committee reported seven cases of diphtheria and one death during the week. The treasurer's report showed \$32,600 received during the past month. Superintendent William Allison submitted his monthly report, showing that the average number of pupils belonging to the school in the second district court was 4,252, with an average daily attendance of 4,021. The number of students absent during the month on account of contagious diseases was 41.

T. J. KURTZ'S ESTATE.

In the matter of the estate of Thomas J. Kurtz, who died Nov. 18, 1905 at Hot Springs, Arkansas, his brother, J. H. Kurtz has come to Ogden and filed a petition in the second district court praying for his appointment as administrator of the estate of his brother. Accompanying the petition are notices to creditors and to the heirs and sisters waiving their right to the appointment and asking for the appointment of J. H. Kurtz to the position. Kurtz died in Ogden only the time he was taken sick and went east. He left an estate in Ogden City valued at \$37,100 consisting of monies and other personal property valued at \$12,200 and real estate valued at \$25,000 according to the petition. He was a heavy stockholder in the Ogden Sanitarium plant at the mouth of Ogden canyon.

G. A. R. ELECTION.

Dix-Logan post of the G. A. R. at its annual meeting last evening elected officers for the ensuing year. Delegates were also elected to attend the state convention at 2 o'clock which will be held in Salt Lake next year. The officers elected last night who will be installed at a meeting to be held Jan. 12, 1906, are as follows: Post commander, A. Van Patten; senior vice commander, John Grey; junior vice commander, J. W. R. James, 21, of Spanish Park and Charlotte Evans, 19, of Provo, were granted a marriage license yesterday.

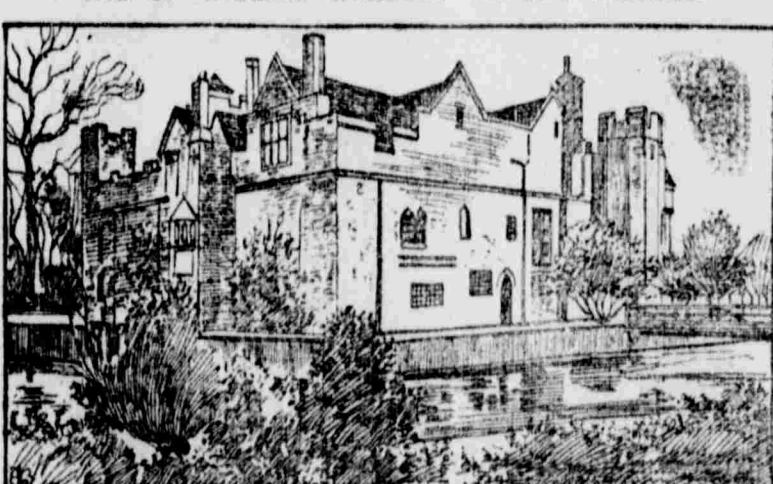

ONE OF WILLIAM WALDORF ASTOR'S CASTLES.



Hever castle, shown in the cut, has been acquired by William Waldorf Astor and is being modernized for his occupancy. It is one of the most historic residences in England and is situated in Kent. It was originally a stronghold as well as a residence and was at one period of her life the home of Anne Boleyn. After her execution Henry VIII, who had confiscated the property, gave it to Anne of Cleves, and she lived there until her death.

STAGE DEVICES IN ENGLAND.

"I was standing behind the scenes talking to Chauncey Oloott; the scene was a Swiss village and the actor was playing the part of a modern Alpine hunter. Suddenly there was a click, a whirr, and semi-darkness. Oloott had gone and I stood behind the offside of a big canvas scene. The machinery had turned the stage around in the time of telling it. The stage of huge proportions, probably the largest in Great Britain, is 80 feet deep by 100 feet in extreme width. The floor is wholly fireproof, being constructed of concrete, steel and oak.
