O. S. L. CUT-OFF CONTRACT SIGNED

Commencement of Big Improvements Contemplated by Railroad Company.

JAMES RILEY CALLED HENCE.

Dr. George Thomas Goes to A. C.—Suspended Plain City Burglar in Jail—June Weddings.

Ogden, Utah, June 8.—The first steps taken towards the railroad improvement to be made in Ogden by the Harriman people were begun yesterday afternoon by the signing of a contract with the Utah Construction company for the building of the Sand Ridge cut-off. The amount of the contract is not given out, but it is a large one, and provides for the work being commenced as soon as possible and pushed with all possible speed to completion.

General Manager W. H. Wattle of the construction company returned home yesterday to fix up the contract and organize and get the grading and in readiness to go right ahead with the work. The construction company will have to build a temporary bridge over the Weber river, all the work at the largest cut and grade will be brought into Ogden and used in leveling up and putting the depot yards in excellent condition, which will be an important improvement to the local yards. The work will be done principally by steam shovels, although a number of teams will be employed and probably 200 men, and there are plenty of men here seeking employment the company will not be short of men.

There will be about 10 miles of grade work to be done, some of it quite heavy, as the cut-off after leaving the main line near Thirtieth street, takes a westerly direction towards Layton and does not join the Oregon Short line track again until near Layton, Utah county. When the cut-off is completed it will make the line much shorter than at present, and the most important feature, and the Oregon Short line train from the south will be able to pull direct into the Union depot yards instead of having to go around a big curve and having to back up as is the practice now.

The railroad company is going to build a large iron bridge across the Weber river when the work is completed. The other big improvements which will be commenced in a few days are the new bridge at the foot of the hill.
