

Hong Kong, 6.—The French forces under Admiral Lespes, which commenced an attack upon Tamsui, have captured and occupied the town. Lespes has sent three battalions to effect a junction with Admiral Courbet.

ESSEX, 6.—Fourteen children while playing in a boat to-day on the river Drave capsized and all were drowned.

LONDON, 5.—Telegraph's Paris correspondent says he has reason to believe the United States Government is continuing its generous efforts for mediation in the difficulty between France and China, a mediation by which Ferry made probably find the only means of exit from the embroglio in which France is entangled. The correspondent adds: The United States, and not Germany, will have the last word in the Chinese question.

A Times Pekin dispatch of Saturday's date: Your correspondent is assured on high authority that China is ready to submit to arbitration, and will abide by the consequences. The Foreign Committee at Kelung is safe. No casualties to the men of war before Tamsui are reported.

PARIS, 5.—Courbet telegraphs: We completed the occupation of Kelung without resistance. The batteries at Tamsui were dismantled. It will be necessary before proceeding to the coal mines to fortify the principal positions so as to enable a small force to hold them. The sunken junks and torpedoes in the river, are being removed. Col. Negrier is massing his troops to march against the Chinese in Tonquin. An engagement is soon expected. Courbet has ordered Lespes to act very cautiously at Tamsui and not land his forces unless able to hold his position.

At Longchamps races to-day, a mob, dissatisfied with the riding of an English jockey named Sharpe, pulled him off the horse and brutally kicked and beat him. The horse was also injured by blows from sticks, stones and umbrellas. Sharpe was carried into the weighing enclosure in a critical condition. A violent row followed, the mob breaking into the enclosure. Soldiers on duty were compelled to guard the place from the infuriated crowd, and one of whom was seized by three jockeys and only escaped lynching by the interference of the police. The jockeys had already stripped the fellow's clothes off and were about to hang him. The weighing room was besieged by the rioters for half an hour and another English jockey was maltreated.

Cairo, 7.—Advices from the Nile state that after the stranding of the steamer, on which were Colonel Stewart and his men, three natives came on board and stated to Colonel Stewart that he was only a short distance from Marawee, which they could reach on foot, and where they could get assistance to float the steamer. They offered to guide them there. Colonel Stewart and two companions started for the village, and when they had traveled out of sight of the steamer a number of men sprung from ambush and murdered the party. The rebels afterwards attacked the steamer, killing all aboard except four.

M. Barriere, French diplomatic agent has received a telegram stating M. Herbin, French Consul at Kartoum, was killed at the same time as Colonel Stewart. His party was massacred by Arabs.

MADRID, 7.—During the past 24 hours there have been four fresh cases of cholera. One death is reported in Spain. Several suspicious cases have appeared at Barcelona, and it is feared they are cholera.

Rome, 7.—During the past 24 hours there were 43 fresh cases of cholera, and 27 deaths; in the city of Naples, 21 fresh cases, and 17 deaths.

CAIRO, 7.—Lord Northbrook, British High Commissioner, proposes the abolition of the Egyptian army and the substitution of a good police force instead. The Egyptian ministry oppose this plan.

ALEXANDRIA, 7.—The camel corps which is to take part in the Gordon relief expedition, has landed here.

DESERET SUNDAY SCHOOL UNION MEETING.

The semi-annual meeting of the Deseret Sunday School Union was held on Monday evening, October 6th, 1884, in the Tabernacle. General Superintendent George Q. Cannon presided.

This was the most largely attended meeting that the Union has ever held, the immense building with its galleries being filled. On or near the stand were Presidents G. Q. Cannon and W. Woodruff, Apostles E. Snow and F. D. Richards, General Officers of the Union, Presidents, and Sunday School Superintendents of Stakes, also many other leading men of the different organizations of the Church. The musical attractions of the evening were the Union Brass Band and the Logan Choir, under the leadership of Brother Alexander Lewis.

The opening exercises were music by the band, followed by an anthem rendered by the choir; and prayer by Stake Superintendent William Paxman.

Sister A. Cowley and Brother E. Stephens sang a duet entitled, "God bless our mountain home," with chorus by the choir.

The roll of Stakes was called, showing that representatives of the Stake S. S. organizations were present from nearly all the twenty-nine Stakes of Zion.

Elder George Reynolds then, by request, read a comprehensive historical review of the Union, prepared by a

committee appointed for that purpose. It was listened to with deep interest. The next exercise was a glee by the choir.

GEN. SUPT. GEO. Q. CANNON

Remarked that he had heard with delight the favorable report just read, and in saying this he felt sure he but uttered the sentiments of all who listened to it. He regretted that Brother Goddard could not be present. In justice to his own feelings, as well as to the worth of his co-laborers, in this work. He felt to pay a high tribute of praise to Brother Goddard and to Brother Wiles, now absent on foreign missions: to the late Samuel L. Evans; and to Stake Sunday school superintendents and other officers and teachers of our Sunday schools for their earnest and untiring labors in this cause. The growth and progress of the Union was a matter of wonder and congratulation when we consider the importance to which it had attained and the great amount of good it had accomplished with the expenditure of so little means. The present large meeting and other striking evidences show the rapid growth and increasing interest felt in this movement. The plan of having all the children visited on a Sunday morning and invited to attend Sunday school by visitors appointed to this duty, had resulted in a marked increase in attendance of many of the schools. It is the duty of all the Saints to use their utmost endeavors to promote the efficiency of our Sunday schools; and parents should uphold their efforts by careful training at home and by setting good examples. He invoked blessings on all engaged in this work.

APOSTLE ERASTUS SNOW

Felt an especial pleasure in testifying to the good results of the efforts of the Sunday School Union, and of the officers and teachers engaged in this work throughout the Stakes of Zion, although not specially engaged in the Sabbath school work, he had striven in a general way to aid and promote its cause. The deep interest he took in it made him rejoice in the success that has attended its progress. As a means of restraining and guiding the youth of Zion the value of its influence could not be estimated. The report that had just been read showed that the blessings of the Lord had rested richly upon the labors of those engaged in this good work and he hoped to see the report printed in appropriate form for future reference. He thought the success of the Union was remarkable and not equalled by anything of the kind elsewhere.

A glee was sung by the choir.

PRESIDENT W. WOODRUFF

rejoiced at the prosperity of the Union and every school included in it. He felt to thank God for the shield from evil and for the encouragement to be and do good that is afforded by our Sunday schools to the children. Other institutions also had been organized through the inspiration of the Lord for the instruction and protection of our sons and daughters. And parents should assist in sustaining our Sunday schools, the primaries and the improvement associations by encouraging their children to attend, and by every other means in their power. The labors and responsibilities of building up Zion will fall upon the children of this people. They will have to meet the powers of darkness and evil and stand amid the judgments that are coming upon the earth; and therefore no pains should be spared to train them in the principles of righteousness. And that the Holy Spirit might be poured out upon them and also upon all engaged in this cause, was his prayer.

ASS'T. GEN. SUPT. JOHN MORGAN

felt grateful to have the privilege of witnessing the wide-spread interest taken in this good work. President Young thought that Sunday school work was of so much importance that he discontinued the Sunday morning meetings so that our Sunday schools might be better supplied with teachers and not interfered with. The speaker felt to suggest that all our Sunday schools be held in the morning and at the hour best suited to children's welfare. He recommended regular meetings of the Sunday School officers and teachers of each Stake; also that the officers and teachers of each school meet together once a month; that secular books be excluded from our Sunday Schools, as class books, our Union and Church publications rendering their use no longer a necessity; also the organization of theological classes in the Sunday Schools, to be held on a Sunday morning or on some evening during the week. He referred to the Brass Band as a pleasing feature connected with the Union.

It was announced that at the monthly meeting of Sunday School Superintendents and Teachers to be held on the first Monday in November, the Thirtieth Ward Sunday School would furnish singing and doorkeepers; and Brother Karl G. Maeser would deliver a short lecture on the best mode of conducting a Sunday School.

General Superintendent Cannon made some

CLOSING REMARKS

in which he commended the Union Brass Band. Stated that it is the desire of the First Presidency that those who make capable Sunday school officers and teachers

should not be taken to act as home missionaries. He hoped that Presidents of Stakes would be actuated by the same spirit that President Young was, and not permit any meetings or gatherings, of less importance than Stake Conferences to be appointed on the Sabbath so as to interfere with the Sunday schools, either in their attendance or the usual times of holding them. Other hours or days could be appointed for any other meetings or business except the Stake Conferences. This is the express wish of the First Presidency, who had urged it before. He endorsed the suggestion of Assistant General Superintendent Morgan that all our Sunday schools, so far as practicable, be held about 10 o'clock of a Sabbath morning. These things were not new, but they were of great importance. He expressed his thanks to Brother Lewis and the Logan choir for their presence and, at his suggestion, the congregation manifested their appreciation of the pleasure the singing had afforded them by a unanimous vote of thanks.

Meeting closed with an anthem by the choir and benediction by Apostle F. D. Richards.
