FOURTY-SIXTH CONGRESS.

CONGRESSIONAL.

SENATE.

WASHINGTON, 2.—Hear introduced a resolution instructing the Judiciary committee to report whether any American citizens have been arrested or imprisoned for petitioning this body concerning a title to a seat in this body of a Senator from their State, adopted.

After the morning hour, unfinished business, the Fitzhugh Porter bill was resumed, Mr. Randolph's amendment being the pending question.

Logan opposed it.

HOUSE.

WASHINGTON, 2.—On motion of Blackburn, the morning hour was dispensed with. Blackburn said he intended to call the previous question on the revision of rules.

Conger being informed that Blackburn would not permit a year and may vote on the amendment striking out from the twenty-first rule the proviso allowing political leaders on appropriation bills, he understood the republican side they would stay here silent a month or two months to prevent a vote upon the rules.

Blackburn said he was obeying the instructions of the committee.

Conger asked if republican members had agreed to the previous question.

House asked Blackburn to yield to him for an amendment allowing members in case their bills are not reported in sixty days from the committee to move to suspend the rules and pass the bills.

Blackburn declined.

Garfield and Frye stated they had agreed to the previous question and explained their reasons.
