Claim for Property Seized by Johnston's Army in Utah.

WASHINGTON, 9.—Butler read a telegram from the Mayor and a large number of citizens of Springfield, South Carolina, urging the Senators from that State in Congress, to use their influence in defeating the oleomargarine bill which the signers declared the worst form of protection. "Let the people try oleomargarine," they say, "as they would any other article of food."

After reading the telegram, the Senate proceeded to the consideration of bills on the calendar under the five minute rule.
