From here to the hill where the dam and goats cheese were shown was a short distance, but the great crowd made it rather difficult to get through. Some of the cheeses were finished in very fine style, having been coated with fluted oil, which made the outside shine on these round cheese disks like glass.

Some were made in plastic form and some coated with a purple coloring matter and some were wrapped in oil paper. Most of the cheeses for export are filled on the outside and wrapped in foil. When not in use, they are wrapped what open in appearance. There was also a large exhibit of goats, and quite a lot of tanning. The latter did not look very tempting. - H. B. Dow in Montreal Herald.
