

# SOLIDITY OF GERMAN CREDIT

Prussian Minister of Finance Talks About Campaign Being Made Against It.

## CAUSE OF MONEY SCARCITY.

Is in Consequence of Country's Extraordinary Prosperity—London and Paris Centers of Agitation.

Berlin, Oct. 12.—Baron von Rheinbaben, Prussian minister of finance, today received a correspondent of the Associated Press, to whom he talked concerning the campaign that is being made in Paris and London newspapers against the solidity of German credit and in which it has been made to appear that Berlin bankers have sought to influence the foreign policy of Germany by urging that French money be loaned in the present situation to uphold German public and private finance.

"The scarcity of money in Germany," said Baron von Rheinbaben, "is in consequence of our extraordinary prosperity. The creation of additional means of production and the immense extension of commercial operations have absorbed the existing capital and thus fresh accumulations derived from current activity. Many holders of state securities have sold them to meet industrial requirements or share with their money in other dividends of prosperity."

"German government stocks have not felt this tendency more than some of the other European countries, although it would not have been unreasonable if they had done so, because in Germany the investment of savings bank deposits and of the holding of various kinds of trustships is not compulsory to the extent that it is in France and England, where immense sums are kept continuously in custody by the operation of the law. In the same manner at the national banks in the United States are required to invest in government bonds. We should do the same in Germany and I have drafted a proposed law on the subject of savings banks."

"Although German funds have not been shaken in this crisis to the extent that they have in other countries, they have not fallen proportionately more. If foreign countries wish to buy our excellent and strongly guaranteed government securities, we are glad to sell, but we have no occasion to take any steps whatever to induce them to do so."

## LAURIER DECLINES.

To Express an Opinion on Asiatic Immigration Question.

Vancouver, B. C., Oct. 13.—Sir Wilfrid Laurier, premier of Canada, has refused to gratify the desire of the Vancouver Asiatic Exclusion league for an expression of opinion from him on the Asiatic immigration question. Following the meeting of the league last Monday night Mr. Gordon Grant, secretary, telegraphed to Sir Wilfrid, requesting him to state his attitude on the exclusion question. The following reply has been received from him:

"I am very sorry I cannot comply with your request for an immediate expression of opinion. It would seem to be unfair that I should not be allowed the privilege of forming my own conclusion upon as ample information as I can obtain."

## BURGALAR KILLS POLICEMAN.

Peoria, Ill., Oct. 13.—During a pistol fight with a burglar who had broken a residence of several thousand dollars' worth of diamonds, Ed Barrett, policeman, was shot and killed early this morning. The man who fired the shot escaped. This is the second murder of the kind in Peoria in five days.

## TO PAY JAPS DAMAGES.

Vancouver, B. C., Oct. 13.—W. L. Mackenzie King, deputy minister of justice of Canada, has been appointed a commissioner to assess and pay the damages suffered by Japanese residents in Vancouver during the riots, and will leave for the Pacific coast on Monday or Tuesday.

## NEW CHANNEL OPENED.

Salt Lake, Oct. 14.—Water was turned into the new channel of the St. Mary's river, West. Needles today, opened a new channel over two miles in length, 9,000 feet of which is cut through solid rock. It is 300 feet in width with a depth at minimum stage of water of 22 feet. The new channel will be formally opened to navigation in the spring. The project has cost \$100,000.

## AMBUSHED BY INDIANS.

Gonzales, Oct. 13.—Jesus Brocman and Roberto Robles, members of the southwestern families in this section of the country, were ambushed yesterday by Yaqui Indians. Brocman was killed outright and his companion fatally wounded.

## CHINESE DEGREES.

Graduates of American Colleges Are Awarded Honors.

Pekin, Oct. 13.—The conferring of degrees by the board of education upon foreign educated Chinese has just taken place and again the graduates of American colleges have been awarded the honors in seven of the highest Chinese degrees granted. Of these, four went to University of California graduates and one to a graduate of Leland Stanford, Jr., university. This was the third annual conferring of degrees. Since the graduates of American colleges achieved such noted distinction in 1906 a high spirit of rivalry has existed between Chinese and Japanese schooled Chinese, and this is supported by the patriotic feeling in Japan, where the number of Chinese students is increasing annually.

Athens, Oct. 13.—In the presence of the crown prince, representing the king, the ministers, high dignitaries and a vast crowd of Greeks, there occurred today the unique ceremony of laying the foundation stones of the new cities of Anchialos and Euxinopolis which the government will build near the coast of Albania in Thessaly to provide homes for refugees from Greek cities in Bulgaria.

## FIRE SWEEPS RANGES.

St. Paul, Minn., Oct. 13.—A special to the Pioneer Press from Great Falls, Mont., dated Saturday, says that a great prairie fire is sweeping the range in the eastern part of the state and that 80 square miles of choice grazing ground in the vicinity of Culbertson has already been burned over.

## BRUTALITY ON CONGO.

Paris, Oct. 13.—The Matin's Brazza correspondent says that advice from the French Congo are to the effect that a number of white officers have been arrested there charged with brutality toward natives. Sensational revelations are expected to follow.

## A GOLDFIELD MURDER.

Goldfield, Nev., Oct. 13.—Mike Karich, a Silverton, 36 years of age, was shot and killed while standing in the door of his cabin in the rear of 1004 Broadway, at midnight last night. The sheriff's office is looking for Tom Huovola, another Slav, who lives in the door of the building leaving the locality hurriedly immediately after the shooting. The cause of the murder is unknown.

# WILL NOT OPEN WITH PRAYER

Motion to Inaugurate Philippine Congress With Invocation Defeated by One Vote.

## STRANGE REASON WAS GIVEN.

Was That Church and State Should Be Kept Separate—Taft's Influence Will Be Felt.

Manila, Oct. 13.—Great interest is shown in the first Philippine congress, which will take place this week, and the arrival of Secy. Taft, which comes at an opportune time in the inauguration of the Philippine home rule.

Already the contending political factions are showing great activity and at the caucus recently held the first brush occurred over a motion to have the assembly proceedings opened with prayer. This was defeated by one vote, on the broad ground that church and state should be kept distinct.

The caucus was attended by 38 delegates. The position of the assembly on questions relating to the political future of the Philippines is expected to be determined by Secy. Taft, in his address opening the session. This is the view held by Filipinos as well as Americans. The latter are generally in favor of a specific pronouncement on Philippine policy. The purpose of legislative action will depend mainly on the result of the fight of the domestic radicals for continuance of the National party.

The Nationalists, when united, exercise controlling influence, but their internal divisions give the Progressive Independents the balance of power. It is charged, so you can see, that the play much part in the assembly's affairs, owing to personal differences within the parties.

Guerrero, one of the native leaders in Manila, backs Gomez in his promise to secure the repeal of the drastic "flag sedition" laws. If this repeal is carried through, other radical measures probably will follow. The conservative classes declare that the repeal of the laws is an ultra-conservative course.

The governor-general and the officials of the Philippine commission think that the chief activities of the assembly will be devoted to the enactment of legislation for the general improvement of the islands.

Manuel Queson will be the candidate for speaker. He is believed to be favorably regarded at Washington and his election gives assurance that no resolution for the independence of the Philippines will be considered. Queson is one of the two delegates from Tayabas. He is a lawyer and in the last insurrection was a major in the Philippine army.

## COLUMBUS DAY CELEBRATED.

Santa Cruz, Cal., Oct. 13.—The 415th anniversary of the discovery of America by Christopher Columbus was celebrated here today under the auspices of the Knights of Columbus. Thousands of knights from all over the state participated. The exercises were unique in that the incidents of the landing of Columbus were represented by knights in costume.

## SOME NEW AND NOVEL STAGE PRODUCTIONS.

New York, Oct. 13.—Those who follow the trend of affairs of things theatrical must turn their eyes to New York this week if they would keep pace with the new and novel in stage productions. During the past few days several plays were tried out in cities other than New York, but this week New Yorkers will have the best chance for a new play. There are five new productions in important theaters, the revival of grand opera in English, the dedication of the newest and probably the handsomest of the new playhouses, the dedication of the new playhouse in this city. Some of the new plays come to New York after a try-out in other cities, but New York is disposed to regard the first performance on Broadway as the real test of popularity and success.

The event of widest theatrical interest, probably, is the dedication of David Belasco's new theater, the Stuyvesant, by David Belasco in a new play, "A Grand Army Man." This play was written by Pauline Phelps and Marion Short, but was thoroughly revised by Mr. Belasco and has already been favorably received in other cities.

## COMO'R BRIGGS INSANE.

Picked Up by Paris Police While Wandering About the Streets.

Paris, Oct. 13.—Commander John Bradford Briggs, U. S. N., arrived, was picked up today by the police while wandering aimlessly in the streets and placed in a hospital for the insane. Subsequently he was transferred over to Capt. John C. Fremont, naval attaché to the American embassy, who placed him under medical treatment. A dispatch from Paris on Friday said that Commander Briggs' actions were causing alarm to his friends there. He seems to be suffering from the hallucination of persecution. That morning he had created a scene at a prominent hotel by claiming that 500 persons were pursuing him.

## STRUGGLE FOR ILLINOIS CENTRAL MAY GO TO COURTS

Chicago, Oct. 13.—It is possible that the struggle for the control of the Illinois Central railroad between Stevenson and K. H. Hartman may be taken into the courts.

If a legal battle should be precipitated, Mr. Fish was closed today for several hours with his attorneys, but would not admit affirming the report that he was about to institute proceedings to restrain the Illinois Central stockholders from holding their annual meeting.
