

## MANY CYCLE FANS AT THE SAUCER

Last Evening's Attendance Was  
The Largest of the Season.

RACES WERE INTERESTING.

In Motor Paced Match Race Samuelson

The program of bicycle races at the saucer track last evening by Manager Schefski attracted the largest crowd of the present season. In fact, it is claimed by the management, that the attendance last evening was as large as any last year, all of which goes to show that the sport is becoming more popular than ever. The seating capacity of the track was taxed to its limit, and the crowd was of the good-natured, joyous sort. As if to be in accord with the order of things the races were exceptionally good, and every event evoked excitement and applause. The finishes were of the whirlwind order and the professionals had to fight hard to hold their own with the amateurs. It seemed as if every rider who competed, did his very best last night, and the crowd thoroughly demonstrated its appreciation.

Of course, the principal event was the 100-mile match race between Clem Turville and Billy Samuelson. These riders have been rivals on the track for many seasons and each was determined to win. The race was a hard fought one, and the crowd was on its feet all the while. In the start the Provo had the pole and held it for four miles when Samuelson's pace made a jump and Turville took the lead, which he held for two miles. Samuelson then tried to make a sneak attack on Turville and for several laps the two put up a game hard fight, going side by side around the steep track. Billy was compelled to drop back but tried it again in the ninth. This effort was a jump and Turville took the lead and held it until the end of the race. The five-mile tandem lap race for the amateurs furnished an exciting race between two of the teams who were after lap money. The prize fell to Agaz and Burris. The race was won by Agaz and Burris. The big three, Hoffman, Hopper and Stevens put up a game fight for first money in the mile handicap for professionals. Hopper made his jump in the fifth lap with Hoffman hanging to his rear wheel. ## NO DEFINITE ACTION.

President Lane Talks About Pacific  
National League Plans.

President Lane of the Butte Baseball club has been interviewed by the Butte Inquirer about the story about the Pacific National League taking Salt Lake into the circuit. The story goes on to say: "The president answered, in answer to questions, that there had been some changes talked of, although no official action had been taken or formulated by the members of the Pacific National League. He did not believe that the circuit mentioned in the dispatch would be formed this year at least. It was understood by the president some time ago that Mr. Hart, who has been in the California clubs to a large extent this year, furnishing a large share of the capital, was willing for a change of thought best by the Pacific National management."

"It is not believed that the clubs of this league will relish another trip to California, especially in the case of the Montana clubs. Mr. Hart, President Lane says he does not believe that such a trip will be made again. It is further understood that the addition of Oakland and Sacramento to the league, Angeles and San Francisco clubs will be made and a state league formed to combat the California outlaws. This, it is understood, Mr. Hart's idea. Hart has stood firmly by the league although his club has been a losing proposition, and it is not the intention of the Pacific National to desert him unless he himself desires a change."

"If such a change is made it will mean that the last season's circuit will be resumed with the possible addition of a Utah club to replace one of the other coast teams. Then, if the outlaws still remain in Seattle and Portland, they will be forced out of the territory if it is necessary to open the gates, figuratively speaking, of the Pacific National league grounds in those cities."

"All this talk has been in the air for weeks, but nothing definite has ever come of it, and what the outcome will be remains to be seen. As for the above dispatch nothing is known here of the movement reported."

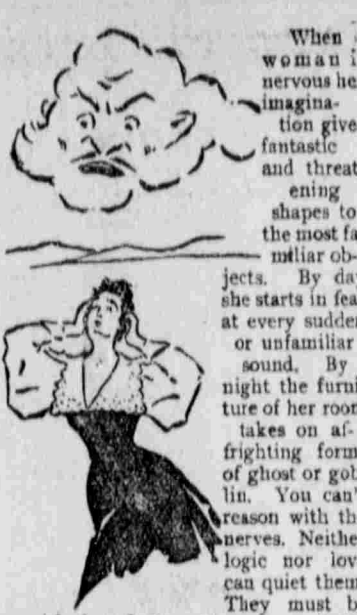
## IDAHO MAN SHOOT SOME.

Gets Second in Grand Western  
Handicap at Denver.

Denver, June 16.—The Grand Western handicap at targets was won this morning at the Denver Trap club's grounds. The officers in charge of the tournament are Fred C. ## KING PETER A ROYAL PUPPET

Real Government of Serbia Will Be  
A Military Dictatorship.

NO FAVORITE WITH ARMY.

World as Soon Murder Him as His  
Predecessor Should He Oppose Aims  
Of the Revolutionary Leaders.

Belgrade, June 16.—The position of King Peter I. promises to be little more than that of a royal captive. The real government of the country will be a military dictatorship under the leaders of the revolution, Col. Maschin and Col. Mitsichitch. The new king is almost without any personal adherents, and the ruling spirits of the army, it is thought, would just as readily murder him as they did his predecessor, should he oppose their aims.

At present the whole country is under military rule, and although no prefects in the country districts have been removed, this policy has been in effect wherever he goes, even to the telephone. This policy has led to one good result—not a single case of disorder has anywhere been reported. Extremely forcible arguments were found necessary to repress the radical aspirations of a republic.

The foremost advocate of the creation of a republican form of government was Jovanich Schickovics, editor of the Belgrade Odeik. Finding him too impetuous to argue, the conspirators held him to a dinner at the officers' club last Saturday. During the dinner the host told him that unless he agreed to support Prince Peter, there would be no less head in Belgrade that night. The editor yielded to the force of his reasoning and accepted the situation. He is now minister of justice in the new government.

Long Sentence for Gambling.

Spokane, Wash., June 17.—The first case under the state's new gambling law came before Judge Richardson in the superior court today. Prince Charles, pleaded guilty to the charge of dealing state poker. Judge Richardson sentenced Deitch to one year in the penitentiary. Appeal has been taken on the ground that the law is unconstitutional. Graves and Graves have been retained and it is said that all boss gamblers in Washington will contribute.

REICHSTAG ELECTIONS.

Leading Feature Was Success of  
The Social Democrats.

Berlin, June 16.—The leading feature in the reichstag election which was held today was the success of the Social Democrats, who have probably increased their representation in the reichstag by 15 seats and their total vote to more than 2,500,000 or 400,000 more than in 1905. All the parties conceded the success of the Socialists, which has been at the expense of them all.

Gov. Alexieff's financial secretary will be the Russian manager of the customs service at Dainy. The receipts will be deposited in the Russo-Chinese bank.

Will of Henry Grant Morse.

Philadelphia, June 17.—The will of Henry Grant Morse, president of the New York Shipbuilding company, at Camden, N. J., who died suddenly in New York June 2, in J. P. Morgan's office, has been admitted to probate here.

Mr. Morse lived in this city at 209 Walnut street. The will appoints Mrs. Morse, widow, executrix. The value of the estate is believed to be upward of \$1,000,000. Only \$20 is left to each of the testator's five children. All the rest of the estate is left to the widow.
