The Train Dispatchers Will Meet in the Windy City in 1894.

Resolution Passed by the Convention This Afternoon.—To Satisfy Tonight.

The second day's deliberations of the Train Dispatchers' convention were commenced very late this morning owing to the visitors having spent much time in their drive about the city and the inability of the respective committees to prepare their reports in time.

Today's Proceedings.

The first business of importance was the presentation of the report of the executive committee for the past year. The report was out of interest to the members of the association but it was decided that its publication would be detrimental to the interests of the association and were withheld.

A lengthy report on the committee's annual dues was read and adopted after which an amendment was passed to cut this afterwards.

Afternoon Session.

On resuming this afternoon the following resolution was presented by J. F. Mackie:

Resolved, That this convention of the T. D. A. of America, assembled at Salt Lake City on the 10th day of June, 1893, confirm the action taken at its last convention, and declared:

That in view of the adoption of any action to-day to establish or disrupt relations which should exist between the Train Dispatchers and their superiors, if that is right and necessary that train dispatchers should have the entire confidence of those who employ them, so far as to whom and for what they serve, as expeditious and honest all circumstances to be called upon. That we regard it impossible for such loyalty to co-exist with any obligation to any other organization.

Train dispatchers will do their duty from time to time as shepherds superior to conflicting interests. It further decides that it is a duty owing to our members as well as the railway service at large in case of alleged injustice to any member of the association, or any member of the family of any member of this association, to have every investigation of every effort of association with loyalty made to settle redress for such investigations shown.
