CINCINNATI, O., 18.—The *Gazette's* Charleston, West Va., special says that the workmen employed on the Government locks in Kanawha River and at Brownstown, West Va., have struck for higher wages; some two weeks ago the contractors brought fifty negroes from Richmond, and on their arrival this evening they were met by about two hundred whites, who insisted upon their return. The latest report from Brownstown says the negroes are in the contractors' office, and the whites have sent runners into the surrounding country for the purpose of collecting a mob. Trouble is feared to night, unless the negroes are sent east. Brownstown is ten miles from Charleston.

ST. LOUIS, 18.—The *Globe-Democrat* special from Chamois, Mo., says that Col. A. A. Spencer was assassinated in the court room at Lynn Creek, last evening, by a stranger giving the name of Jeffreys; the only explanation of the affair is that Jeffreys asked Spencer what he had done with his wife and children, and immediately drew a revolver and shot him three times, twice through the head. Jeffreys made no attempt to escape, but surrendered.

CLEVELAND, O., 18.—The Emperor Dom Pedro and his party arrived in this city to-night; they made a stop of twenty-five minutes and were driven to Lake Shore Park, and viewed Lake Erie, and then left for Chicago.

QUINCY, Ill., 18.—The levee south of this city has broken in three points, and a large portion of the bottom on the Illinois side is overflowed; opposite Hannibal houses and barns have floated away, and the damage that has been done cannot be estimated. The entire population of the bottom have fled to the bluffs, in many cases leaving everything behind them. Meetings have been called at Hannibal to assist the unfortunates. Much suffering is sure to follow this great calamity. The river declined one inch this p. m., and it is believed that the worst is over.

LOUISVILLE, 18.—The Louisville, Paducah and S. W. Railroad, now in a receiver's hands, has been ordered to be sold by the marshal of the United States Court of this district, at a time to be hereafter specified.

WASHINGTON, 18.—The committee on rules, to-day, agreed upon the basis of a report adverse to the position of Chas. H. Smith, in advertising to collect bounties in the event of the passage of the pending bounty bill while acting as journal clerk of the House.

There is the authority of the President for denying the statement that he had requested the discharge from the public service of employees who were appointed to their positions at the request of Gen. Babcock.

U. S. District Attorney Van Dyke telegraphed his resignation on Saturday, to Senator Sargent, saying that the office is not worth the abuse and annoyance to which he is subjected; Sargent then obtained the President's leave to offer the place to Judge Coghlan, and the latter accepted, preferring to remain in San Francisco rather than live in Utah. His nomination as District Attorney for California will be at once sent in, and a vacancy thereby created in the chief justiceship of Utah.

The President sent to the Senate, to-day, the nomination of John M. Coghlan, to be U. S. Attorney for the District of California, Gardner C. White, to be Postmaster at Carson City, Nev., Charles H. Lord, at Tucson, Arizona.

The President vetoed the presidential salary bill; the message was not read to-day.

That the powers heretofore vested in the supervisors of internal revenue be given to revenue agents, and that the services of supervisors be dispensed with, which will save the Government about one hundred and thirty-eight thousand yearly.

Bristow has issued the following circular as instructions concerning the issue of silver coin of the U. S. in the place of fractional currency—

"TREASURY DEPARTMENT, Washington, April 18.

"By virtue of the authority vested in the Secretary of the Treasury by the second section of the act entitled an act to provide for the defi-

ciency in the Printing and Engraving Bureau of the Treasury Department, and for the issue of silver coin of the U. S. in place of fractional currency, approved April 17, 1876, the several officers below named are hereby authorized, upon presentation at their respective offices, for redemption of fractional currency, in sums of five dollars or multiples thereof, assorted by denominations, and in amounts not to exceed one hundred dollars, and to issue therefor a like amount of silver coin of the U. S. of the denomination of ten, twenty, twenty-five and fifty cents; and, furthermore, upon presentation for redemption at the office of the Secretary of the Treasury of the U. S. in this city, of any amount of such currency, properly assorted, and in sums of not less than five dollars, the treasurer is authorized to issue silver coin therefor to the amount of the currency presented; or he may issue his check therefor, payable in silver at either of the offices hereinafter named at the office of the party presenting the currency, as far as may be practicable from time to time. Fractional currency redeemed in silver under these instructions by any of the assistant treasurers, or at any designated depositories of the U. S., will be sent in sums of one thousand, or multiples thereof, to the treasurer of the U. S. in this city, the amount to be charged in the treasurer's general coin account as a transfer of funds; and any amount of such currency for which silver has been paid remaining at any time in cash at the several offices will be treated as coin assets, and in no case will such fractional currency be reissued. Fractional currency sent by express or otherwise to officers below named for redemption in silver, under the provisions of this circular, should be accompanied by a letter of advice, stating fully the address of the sender, and how the remittance in payment therefor is desired, and if by the treasurer's check the office at which the check should be made payable. The government will not pay express charges on silver issued or fractional currency presented for redemption under the provisions of this circular. The offices herein referred to are as follows—Treasurer of the U. S. at Washington; assistant treasurers at Boston, New York, Philadelphia, St. Louis, Charleston, New Orleans, Cincinnati, Chicago, San Francisco, and Baltimore, and the U. S. depositories at Buffalo and Pittsburg.

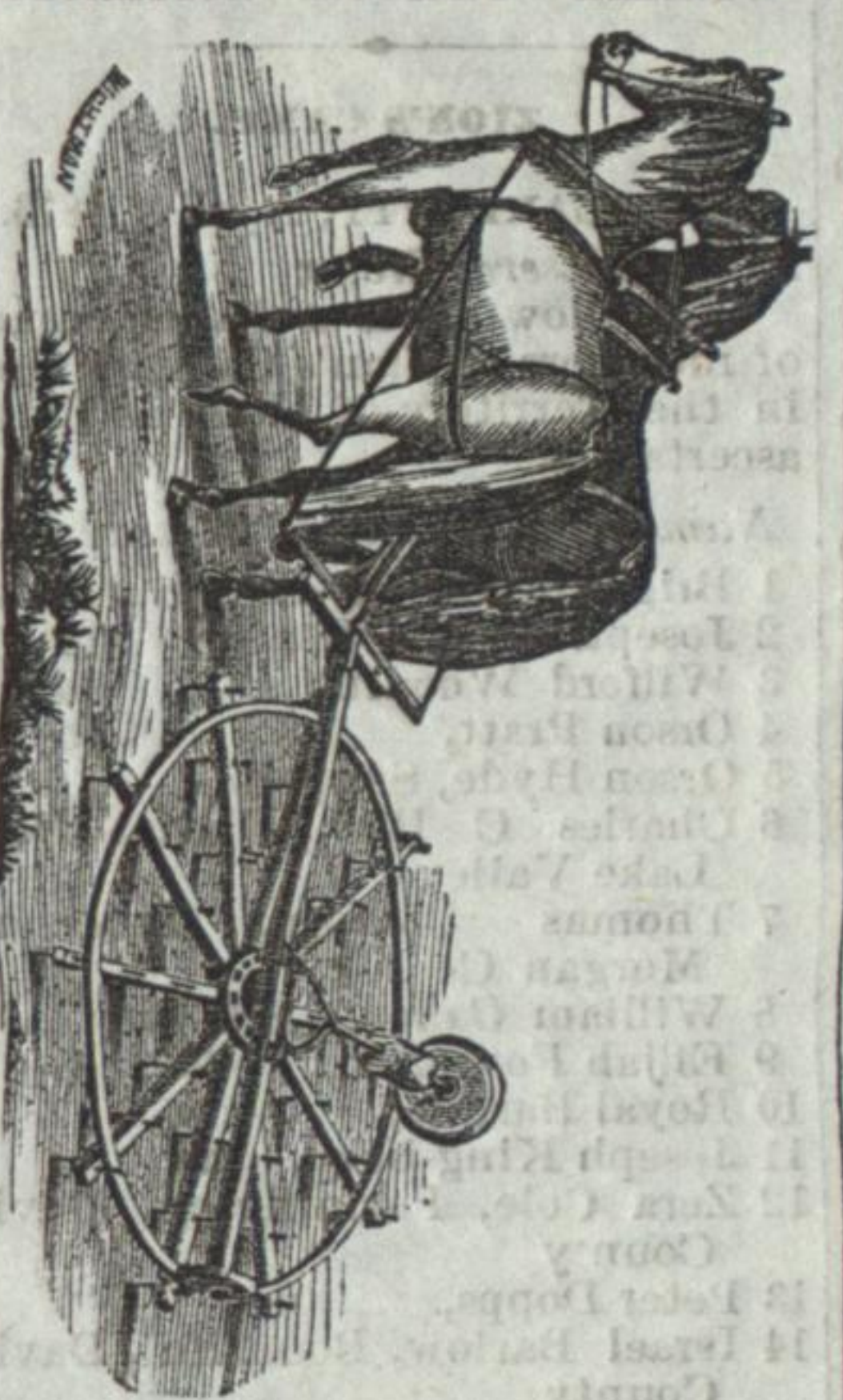
