WASHINGTON, D. C.,
October 18, 1888.

Col. John B. Winder, Chairman Territorial Central Committee of the People's Party:

Having learned from the papers that I was renominated by the People's Territorial Convention as Delegate to the Fifty-first Congress, and as my duties will detain me here several days yet, I take this means of notifying you that I accept the nomination, and am deeply grateful to my constituents for this renewed evidence of their confidence. If elected, I shall, as heretofore, use my best efforts to faithfully represent the whole people of the Territory.

Leave it Alone.

During the past week or two a considerable number of our citizens have received a circular from a San Francisco house, asking that the person addressed send his photograph or that of a friend to the firm and have a crayon portrait made, free of charge. The circular says:

"The only consideration imposed on you will be that you exhibit it to your friends as a sample of our work, and thereby assist us in securing some orders. Also that you promise to get it framed in a suitable frame for a fine portrait, but of course you will not allow a fine portrait to stand around unframed and have it ruined. We trust you will not consider this a 'scheme,' as it is not, but an excellent way of placing specimens of our work in your vicinity. A guarantee of the return of the photo is assured, so have no fear of losing it. This offer is good for ten days. This will be a sample portrait worth \$35, as fine as can be made."

Coast papers say the whole thing is a fraud; that after the portrait is sent another circular will be received, asking \$7 to \$15 for the "elegant frame," a framed picture, worth less than half of the money expended, will be the return. It is better to leave all such risky concerns alone, and obtain whatever articles you want, in any line, from those who do business in a legitimate manner.

From the North.

Last Saturday a woman living in the southern part of the Bench, attempted to commit suicide by taking a dose of laudanum. A physician was summoned at once, and antidotes were administered. She is now on a fair way to recovery. No cause was assigned for her desire to end her own life.

The incoming D. & R. G. train was delayed for an hour about a mile northwest of the depot, yesterday morning. A small house was being moved from its old moorings to a more suitable place. In crossing the D. & R. G. R. R. track the structure tipped over and could not be removed in time for the train to pass. The passengers walked to the depot in preference to awaiting the removal of the house.

Last night a young man, shabbily clad, with a worn-out look about him, approached the railway officials at the depot, and begged of them to pass him to Salt Lake. He told the following story: When Foster & La Rosa's circus had passed through the capital he had engaged with the managers and had followed them to Pocatello. Arrived at this place the managers refused to pay him as well as two or three others who had been engaged simultaneously. Being left without money or friends, he had struck out for home on foot, and last evening, reached Ogden with his feet all cut up. He lived at Graner, nine miles from Salt Lake, and was very anxious to get home, bursting out in tears when refused a passage. The officials gave him money whereby to secure food and lodgings while they investigated the truth of his story.—Ogden Standard, Oct. 16.

Ogden Jots.

A large stock train containing about 35 cars pulled out from Ogden yesterday afternoon on its way east. The stock came from Southern Utah. It was pulled by three engines.

What might have proved a serious conflagration yesterday occurred in the S. P. yard. A U. P. car, loaded with sulphur, caught fire from a spark. The yard-men rushed into the car as soon as the fire was noticed, but the suffocating smoke drove them back. After some difficulty they at last succeeded in putting out the fire. A few sacks were destroyed.

A fire was happily averted yesterday morning at 2 o'clock by the presence of Thomas Luty, the night watchman. Having occasion to go into the center of the block he saw a glowing heap of ashes and cinders near Driver's drug store, which had been thrown out carelessly by some party. He called a couple of officers who at once put out the embers. Had there been a wind blowing the result might have been very disastrous.

Early yesterday morning some of the burglars who have made Ogden their stamping ground, attempted to break into Funge's hardware store. Wm. Pierce had worked half an hour later than usual the evening previous in order to finish putting in some iron bars at the back windows. The bold thieves succeeded in breaking out two of these with a piece of scantling, but finding it rather difficult to make an opening large enough to suit them, gave up the attempt. Another loss of cutlery would doubtless have been the result had the protective bars not been put up in the nick of time.—Ogden Standard, Oct. 18.

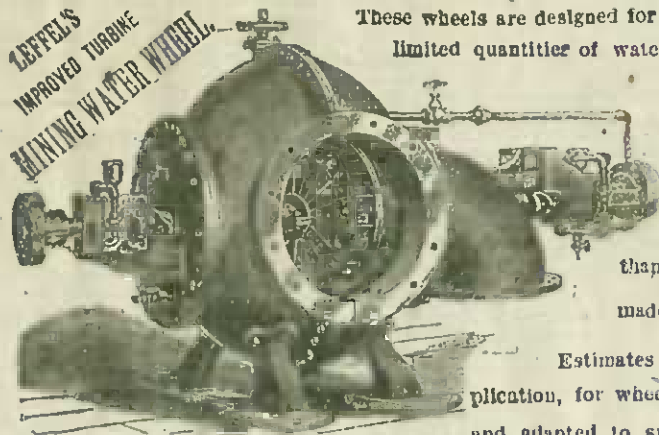
