

Washington, Aug. 31.-The following cablegram was today received by the marine hospital service:

"Glasgow, Aug. 31 -The local board of health declares Glasgow infected with plague. Eleven cases and one suspicious case in the hospital today. "THOMAS."

Glasgow, Scotland, Aug. 31.-Passed Assistant Surgeon A. R. Thomas, of the United States marine service, who is now in the city, will investigate the bu. bonic plague here, and take the neces-sary procentions in regard to outward bound vessels, although he has not yet received instructions from Washington regarding the position of quarantined Glasgow vessels arriving at American There has been no increase in the

number of the cases of the plague in this city and no undue alarm as to the spread of the disease is felt. The authorities are acting with promptitude, and are confident of confining the outbreak within the present scope.

They Propose a National College Dedicated to the G. A. R. Chicago, Ilis., Aug. 31.-With assets
