FORESTY ORGANIZATION

At the Hotel Templeton at Saturday Evening.

Officers Elected and Constitution Adopted. John Park, President; C. A. Whiting, Secretary.

A number of gentlemen met in the parlor of the Hotel Templeton last Saturday evening, February 24th, to organize a County association. The meeting was called to order by C. A. Whiting, who nominated Dr. John D. H. Park, president of the meeting. Park being unanimously elected took the chair and called a general way the object of the meeting.

On motion of Dr. J. T. Huntington, C. A. Whiting was elected secretary for the meeting.

The present item called for the secretary to take a resolution lengthening the object of the association to "the protection of forests and timber." The motion was carried.
