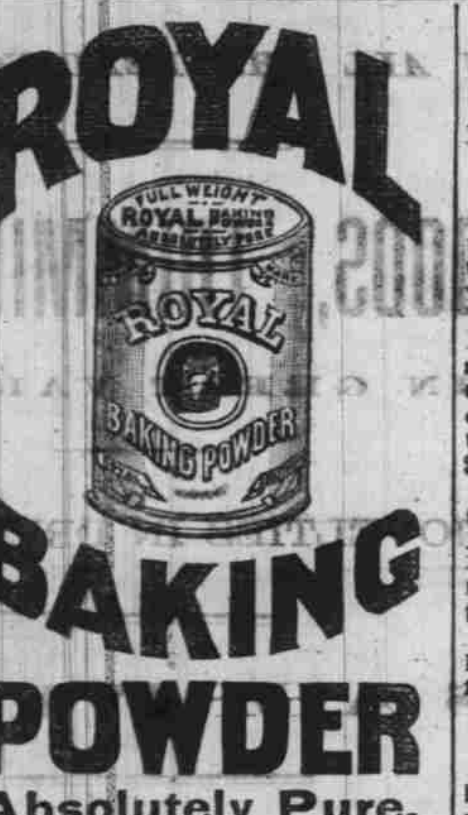

Resolved, That the bill creating a
tariff commission be recommitted,
with instructions to the committee
to report by the first day of April
in 30 days, or at an early date, if it
be practicable, the bill based upon
the following instructions: First,

that all raw materials, meaning
thereby all materials which have not
been subjected to any process of
manufacture, and all waste prod-
ucts, meaning thereby all waste
materials which are fit to be man-
ufactured, and all chemicals which
are produced in this country, and
alcohol for use in manufactures,
shall be placed upon the free list.

Second, that so far as possible spe-
cific duties shall be substituted for
ad valorem duties, and that in de-
termining such specific duties, the
average dutiable value of imports
for three years shall be taken as the
standard of value, and that a higher
rate of duty shall be imposed than
shall be necessary to compensate
for the difference on cost of labor
at home and abroad, except in the
case of such articles as are of value
in the production of such articles.
