

Instructions in hygiene, habits, etc. are given by the lady superintendent.

The discipline of the College forbids profanity, obscenity, the use of tobacco or alcoholic liquors, visiting places at which intoxicants are sold or games of chance carried on, attendance at entertainments not approved by the Church authorities, etc. Boarding houses must be approved by the Principal. A complete registry is kept of the name, standing, conduct, etc., of each pupil.

The College has a large assortment of apparatus of various kinds to facilitate study, including cabinets of geological and mineral specimens, laboratory, microscopes, machines, manikins, fossils, etc. The Stake Library and the principal newspapers, with many scientific and other periodicals, are available to the students.

The faculty is composed of James E. Talmage, D. S. D. Ph. D., Principal; Willard Done, D. B., First Counselor and Secretary; Joseph Nelson, Second Counselor and Assistant Treasurer; John J. Walton, Librarian; Richard Haug, Registrar; Mrs. Camilla Cobb Lady Superintendent, and Evan Stephens, Instructor in vocal music. Among the regular lecturers are: Elder George Reynolds, Elder John Nicholson, Dr. Chas. F. Wilcox, Hon. F. S. Richards, R. W. Young, L. L. B., Don C. Young, C. E., Romania B. Pratt, M. D., Bishop O. F. Whitney, etc.

This institution is well worthy the patronage of the Latter-day Saints. In addition to its efficient teachers and comprehensive course of studies, the theological teachings and religious spirit which form prominent features of the establishment render it specially suitable to the young people of this community. NEITHER "REVOLUTION" NOR "CONTRACT."

"How about the hundreds who voted in the Theatre in this city on the question of organization? How about the absolute revolution in Logan, after the Republicans had carried the school election and Democrats gave up the city ten days before election, when one appeal of the Apostolic, Thatcher made Republican Mormons all over the house tear off their Republican badges? THE FIGURES GIVE THE PROOFS.

THE vote in this city for the Republican candidate for County Collector was 412. The Republican vote for legislators varied from 338 to 385. The vote in this city for the "Liberal" candidate for County Collector was 3732 while the city "Liberal" vote for Selectman was 3794, a difference of 62. The "Liberal" vote for legislators was from 3774 to 3784.

Now compare these figures and it will be seen that a number of Republicans who voted for Kimball as against Williams for Collector, voted for the "Liberal" candidate for the Legislature and Selectman.
