OUR COUNTRY CONTEMPORARIES.

Utah has furnished more homes to the oppressed of other countries than any other Territory, and notwithstanding the number already here and yet to arrive, she has plenty of room for millions more.

Mr. E. Pierce, who was over there yesterday, informs us that Brigham City is quiet and prosperous. The citizens are getting ready to go right to work in constructing their portion of the narrow gauge to Weber county.

We regret to learn that Mr. John Brannan, one of the most popular attaches of the C. P. depot at this place, fell from a freight car last night and was seriously hurt. The worst injury was a severely sprained ankle. He will be laid up several days in consequence.

The owners of the new hotel are very properly dividing their patronage among the people of the Territory. The spring mattresses for the beds were bought and made in Logan, Cache Valley. A number of them were down at the depot this morning, and their make and general appearance speak well for the manufacturer.

The Ogden Junction, Nov. 4—The Union Pacific train last evening was three hours late on account of hot boxes, which caused the speed to be slackened.

New mines of great value have been discovered around Ogden. Some interesting particulars regarding them may be looked for as soon as more definite information can be obtained.

Measures are being taken by a number of gentlemen to bore for oil in this vicinity, as they are satisfied that it can be found in certain localities which have been examined, where there are strong indications of its existence.

Two companies of the U. S. A., one of infantry from Jefferson Barracks, St. Louis, another of artillery, from Governor's Island, New York, numbering in all two hundred and fifty men, rank and file, passed through Ogden on their way to Benicia Barracks, California. Three of the men were left behind, having missed the train bound for the West. They will be sent on this evening.

The movement long contemplated to build up an iron manufacture in this city, thus contributing to the development of the material resources readily available in and around Ogden, has taken definite shape. Possessing every facility that can be desired for the successful execution of a project which will, when consummated, add to the importance of Ogden and to the enrichment of the Territory. There was, when the idea was conceived, but one drawback,—the want of capital. That want has now been supplied. A few weeks ago, Mr. I. E. Brown, of this city, whose long experience gave his opinions great weight among men engaged in manufactures, visited some of the eastern cities and explained to capitalists the great benefits which would accrue to those who embark in the enterprise which

has now assumed a tangible and practical form. Acting upon Mr. Brown's suggestion, Messrs. Parks, of Milwaukee, and Tait, of Pittsburgh, who are connected with extensive manufacturing establishments, came to this city, and after careful examination were satisfied with the advantages Ogden enjoyed in every respect, and concluded to co-operate with Mr. Brown in giving an impulse to the movement of constructing first-class iron works. A company was organized, and thirty acres of ground purchased. The location of the buildings commencing at the corner of Wall and First streets, the site of the machine shop now occupied by Mr. I. E. Brown, between the U. N. and U. P. railroads.

At a meeting of the company held last night Mr. Isaac E. Brown, of Ogden, was elected chairman, and Lucius P. Sanger, of Salt Lake, secretary. It was resolved that the title of the company should be "The Ogden Iron Manufacturing Company." The following directors were elected:

Isaac E. Brown, James L. Horrocks, Ogden; L. P. Sanger, Salt Lake; Josiah Parks, S. Child, J. Meredith, J. R. Williams, Milwaukee, Wis.; Charles Park, Chicago; Wm. Tait, Pittsburgh. The officers of the company elected are, President, Josiah Parks; Vice-President, James L. Horrocks; Secretary, G. P. Brown; Treasurer, G. M. Scott; General Manager, I. E. Brown; Superintendent of Rolling Mill, J. Park; Superintendent of blasting furnace, E. J. Bird.

The capital stock of the company was determined at \$250,000, with power to increase it to \$500,000, to be divided into shares of \$100 each. It was further resolved that a payment of 25 per cent shall be paid at the time of the delivery of the stock, and the balance to be paid according to the provisions to be made by the directors.

Messrs. Tait and Parks have gone East for the purpose of making preparations to supply the establishment with the required machinery, and Mr. Brown, General Manager, will proceed without delay to construct suitable buildings. The enterprise may fairly be considered as inaugurated.
