JAMISON'S INVASION.

Purpose Said to Be the Overthrow
of the Poor Republic.

GROSS ABUSES TO BE REMOVED.

The Foreign Element in Arms Against
the Original Settlers of
the Country.

CHICAGO, Jan. 2.—J. B. Weinberg, of Johannesburg, who is at presentjourning in this city, says that the invasion of the Transvaal was in no sense an effort on the part of England to annex the celebrated South African gold fields. The people of Johannesburg would fight to the death against coming under British rule.

"When the Transvaal was unknown to us it was in gold and diamonds," Mr. Weinberg continued. "The laws concerning the naturalization of new citizens were the same as in the Orange state, and very similar to naturalization laws of the United States. But when the country began to fill up with miners, especially Englishmen, the gold and diamond industries, though changed the laws and made impossible for any one to become naturalized. Then a high tariff was placed on everything that the miners were not likely to buy, and some of the miners had to go to the mining industry. In this way the revenue succeeded in levying fully thirty percent of the taxes on the new population which was destined citizenship in order to prevent the naturalization of the foreign labor force."

Mr. Weinberg continued. "The laws concerning the naturalization of new citizens were the same as in the Orange state, and very similar to naturalization laws of the United States. But when the country began to fill up with miners, especially Englishmen, the gold and diamond industries, though changed the laws and made impossible for any one to become naturalized. Then a high tariff was placed on everything that the miners were not likely to buy, and some of the miners had to go to the mining industry. In this way the revenue succeeded in levying fully thirty percent of the taxes on the new population which was destined citizenship in order to prevent the naturalization of the foreign labor force."

"It was five years ago," Mr. Weinberg said, "that the national union, to remove these grave abuses, was organized at Johannesburg. It took in its membership all the more progressive Englishmen, and the result expressed itself in the demand that the majority of the citizens who would interfere with any attempt on the part of England to annex the country. Even the English residents would oppose any measure for the country's subjugation, in order to prevent the naturalization of the foreign labor force."

"The movement has doubtless succeeded they will never make any way until the old government is overthrown. That it seems to me, is that Dr. Jamison's invading measure, which I am sure, means that he will add his forces to those of the Boer government, and the next that will follow will be that which is accomplished. The movement has been for some time, and the center is not the man that would stop half way measures when once

achieved.

JOHANNESBURG IN ARMS.

LONDON, Jan. 2.—Editor Hesse, of the South Africa Critic, says he has no doubt that Dr. Jamison's forces will be received at Johannesburg, sent since Dr. Jamison's defeat, of such a grave nature that he declined to publish it himself confirmed from other sources.

Hesse has had a long experience in the political arena, and his previous news regarding the present situation in South Africa, in the course of an interview, may be quoted as follows:

"If Johannesburg is the same town I knew, the city has then and other days been in the hands of the Afrikaners. Dr. Jamison's forces have been welcomed by the Afrikaners there, including Americans, who help the English. There are practically no Boers at Johannesburg excepted burghers who are parading the streets."

JAMISON REPORTED SHOT.

PHILADELPHIA, Jan. 2.—It is reported that Jamison will be tried by a court martial and his followers released.

WILLIAM'S CONGRATULATIONS.

PHILADELPHIA, Jan. 2.—Emperor William telegraphed President Kruger as follows: "I express my sincere congratulations to your Excellency and your people, and without appealing for the aid of friendly powers, you have subdued your own energetic action against the armed bands which invaded your country as disturbers of the peace, and the safeguard of the independence of the country against attack from the outside. William."

The latest story circulated this afternoon was that the second body of men advanced from the British Chartered company, numbering about 1,000, which started out to reinforce Jamison, had been cut to pieces by the Boers. This was the force supposed to have been advancing from Biwaau, which was removed, and seemingly confirmed by the fact that there had been an uprising at Johannesburg and that many persons were killed during the disturbance.

THAT SCHLOSSBERG LINE.

The Dispatch to the London Chronicle Explained.

LONDON, Jan. 2.—The dispatch to the Daily Chronicle from a special commissioner at Washington, giving theitherto unpublished correspondence between the governments of Brazil and Venezuela during the period between November, 1894, when Robert Gordon, then a special agent to survey the western territory of British Guiana in April, 1892, when local Indians finally removed the British post which he set at various points in the interior, to form the so-called Schlossberg. His report caused much attention here. The Chronicle calls it a momentous dispatch and reads it "A New Era in the Controversy between the Rio Grande and the Amazonas."

In foreign offices, however, speaking of his dispatches to a representative of the Associated Press this afternoon,

said the correspondence quoted was "correct in its main point." He added that there is much which is unpublished and also the private letters of Senator Forquerio, the Venezuelan minister in Great Britain at that time, that gives a different light on the matter. We will let you know, take particular care, Senator. Once a document is transformed into a statement which would be entirely antagonistic to the American side of the question."
