

THE COAL COMBINE.

President Leibowitz Sees How Consumers are Swindled.

THE PROTECTION OFFERED.

A Tax of Four and a Half Cents Would Tax Them and Protect Consumers.—The Duty for Rebranding.

During the discussion which preceded the passage of the coal arbitration bill by the City Council last night President Leibowitz declared in unmistakable language that it was the duty of the council to equate, as far as possible, the coal article that was going on in this city. He thought that it should be fought with all gusto that companies should be brought to trial. Then referring to the passage of the arbitration bill he said: "The coal combine is a great monopoly and consumers would benefit by the legislation of having them pay what they were profiting. The coal combine was robbing the people every hand. He knew how that organization was effected and for what purpose. There were five mines in the combine, owned by the Union Pacific, Great Western and Pleasant Valley coal companies. Prior to its forming the Union Pacific furnished about 25 per cent of the coal used in this city. The Great Western came from his to twelve per cent, and the Pleasant Valley company the remainder. By the passage of the arbitration bill the coal was to be kept up to the respective proportions of sale. Under existing conditions, if a purchaser ordered back bills and he would not pay him, the bill and collector after January 1st, 1893, in this city after which date the county assessor and collector shall assess and collect the general tax for the city."

If another went by coal would cease, but Back Ridge coal would have to be paid for. That was the state of affairs that confronted the people. The council was duty bound to give it to them just as far as to the people.

The ordinance finally passed and was sent to the Mayor today. He said that he will sign it without delay.

The tax will be three cents after deduction in the sale of coal the hundred weight shall consist of one hundred pounds Aransaswood and twenty each weight shall constitute a bushel.

That every person who transports the coal or selling or delivering coal at retail or wholesale, of whom soever delivered any such coal to this city shall deliver or cause to be delivered to the purchasing agent of the territorial government, when he or she receives the coal or shipping and receiving, and at the time of such sale or delivery, a certificate in writing signed by an authorized weighmaster shall be produced, showing the exact number of pounds of coal as delivered, and either the same is increased or decreased.

Any person who shall violate any of the provisions of this ordinance, or who shall deliver or cause to be delivered a less quantity than 100 pounds of coal for each ton purchased or a nonconforming amount of any part of a ton, or who shall deliver to any purchaser a certificate in writing signed by an authorized weighmaster shall be liable for the penalties, allowing the exact number of pounds of coal as delivered, and either the same is increased or decreased.

The assessment on all property includes the cost of coal, and the valuation of all general taxes levied for municipal purposes, including all taxes for assessment and collector to the manner now or which may hereafter be provided by the laws of the Territory, to the assessment of property and collection of taxes for county and territorial purposes.

The master will come up for discussion by the City Council on Tuesday night.
