

## ELECTION JUDGES ARE SENT TO JAIL

Colorado Supreme Court Give Six of Them Sentences Ranging from Four to Nine Months.

## VIOLATED INJUNCTION ORDER.

Judge Mullins Gives Inclusive Instructions to the Special Grand Jury.

Denver, Dec. 6.—Six more election officers were sent to jail today by the state supreme court for disregarding its injunctive order at the late election. The sentences were as follows: William Reid, 8, 3, Barker, John E. Dixon, and John Sullivan, nine months' imprisonment and \$500 fine, with costs, each; Willis E. Spencer, four months' imprisonment; Charles W. Bunch, three months' imprisonment.

Sullivan was Democratic committeeman; Reid, Barker and Spencer were judges, and Dixon and Bunch clerks in the Ninth precinct, Fifth ward, in this city, the ballot box of which was opened in court last Friday, disclosing many fraudulent ballots.

The court today tried the election contempt case of the Sixth precinct, in the Fifth ward. The defendants are William Bergman, election judge; J. Kitson, election judge, and James P. Mullins and Patrick Reid, Democratic workers.

The charges are that no Republican clerk was allowed, that Republican watchers, C. H. Sanson, was violently removed from behind the rail, that supreme court watchers were not permitted to examine the registration lists and that the Republican challenger's book was taken from her.

J. Fred Roberts, one of the witnesses, testified that repeaters appeared at the polls every few hours in bunches of from two to a dozen, and were allowed to vote.

The court ordered the ballot box of precinct 6, ward 5, opened and gave the contents over to the grand jury to examine. They worked late into the night so as to be able to report to the court tomorrow.

District Judge John I. Mullins today delivered his instructions to the grand jury summoned by him to the criminal court. He charged it to "make a thorough investigation as to all violations of the law growing out of the recent general election."

"In my opinion," he said, "the lavish expenditure of money has been witnessed in this county and state is criminal. I believe it to be at the very root of all of the crime and violations of the election laws which have accompanied our recent elections."

"It ought to be made a criminal offense for any corporation to contribute to any political party."

"It is common talk on the streets and currently circulated in the newspapers that a conspiracy exists to deprive of the governorship of this state one of our citizens whom all good citizens, irrespective of politics, believe to have been honestly elected. It is further openly charged to carry out this conspiracy it will involve the use of force and violence and the use of certain members of the coming legislature."

"It is also charged that immense sums of money have been collected from the various corporations of this city and state to aid in this work. It is charged that even after the official count was completed in many counties of the state and certified to by the proper officials, agents were sent out for the purpose of procuring some one member of these local canvassing boards following in alleged minority reports with the hope that the state canvassing board could be induced to violate the law and disregard its oath of office."

"This is a matter that will tax your patience and ability, but I earnestly urge it upon you for your most careful consideration."

The prosecution closed its case against Max Schradsky, William Schradsky, Samuel Slakin, Max Slakin and Katie Pliska, defendants in the action before United States Commissioner Capron, charging violation of the statute of the United States in preventing Republicans from voting at the recent election.

## NO TRACE OF BANDIT HAS BEEN FOUND.

Man Who Looted Wells-Fargo Express Car Has Made Good His Escape.

## SCORES OF DEPUTIES ARE OUT.

Are Patrolling Railroad—Thousand Dollars Reward Offered for Robber's Capture.

Los Angeles, Dec. 6.—Notwithstanding that scores of deputy sheriffs and police officers are patrolling the Santa Fe railroad, nearly all the way from Daggett to Needles, and the surrounding country is being searched to the remotest corner for some trace of the bandit who yesterday looted the Wells-Fargo express car at Daggett, Cal., after shooting and perhaps fatally wounding Express Messenger Evan Roberts, the man is still at large.

The first suspect arrested, a negro, who was taken into custody at Barstow yesterday, arrived in this city today in charge of officers, and has been lodged in the city jail. Wells-Fargo officials say, however, that they do not believe he is the man wanted. Several other persons have been apprehended at various places on suspicion, but it is believed that the right man has not yet been captured.

The Wells-Fargo Express company has offered a reward of \$1,000 for the capture of the bandit. This offer has been supplemented by one for a similar amount from the Santa Fe Railroad company and \$500 from the state. The large reward has attracted a number of persons, who are searching every foot of the territory in the neighborhood of the hold-up where a man could see himself, and it is not believed that he can possibly succeed in escaping. The country for miles in every direction from Daggett is a barren desert, with no avenue of escape excepting by way of the railway.

Messenger Roberts is still alive and the physicians say that he stands about one chance in 100 of recovering. He is in the custody of the state, but it is charged that even after the official count was completed in many counties of the state and certified to by the proper officials, agents were sent out for the purpose of procuring some one member of these local canvassing boards following in alleged minority reports with the hope that the state canvassing board could be induced to violate the law and disregard its oath of office."

## BEBEL ANALYZES GERMAN BUDGET.

National Debt During the Year Has Increased One Hundred Million Dollars.

## BUT HE IS NOT UNANSWERED.

Von Buelow Denies that Germany is Spending More on Army Relatively Than Other Nations.

Berlin, Dec. 6.—Herr Bebel, the Socialist leader and the keenest critic of the government at all times, analyzed the budget in the Reichstag today. Secy. of the Treasury von Stengel, he said, had sketched on Saturday the deplorable financial situation of the empire in terms so true that he regretted the French custom could not be followed and the speech be posted throughout the country as a ministerial declaration of the position into which the country had been drawn by the government's policies, the national debt increasing \$100,000,000 during the year. Why, then, should the army be increased? Why should the navy be increased? Why should these and other policies that together formed the so-called "world policy" be carried forward on an enlarged scale when the country corresponds with the Russian conditions? If the "world policy" is essential to Germany as pursued in former years, why expand that policy by loans that mortgage the empire's future and lay permanent burdens upon the industrial activities of the country?

Herr Bebel, who spoke for about three hours, discussed the details of the appropriations, deducting therefrom the amount which he did not and then bite his finger tips restlessly or nervously smooth his hair, replied to Herr Bebel.

The chancellor agreed with Herr Bebel in the statement that the country was being brought into the world of the future by the "world policy" which he had just described. "There is further reason while the governments of all the great powers are maintaining their present peace policy."

Referring to Herr Bebel's description of the internal conditions of Russia, Count von Buelow remarked: "When Herr Bebel warns us over Russian autocracy he condemns himself without knowing it, for the manner in which he looks at our own party corresponds with the Russian conditions that so greatly displease him. The order of things he wants to introduce with us would lay Russian despotism in the shade."

Taking up the case of the German fishing vessel Sargus, seized on by one of the warships of the Russian Baltic squadron, and other incidents, Chancellor von Buelow said the German government promptly took steps to get satisfaction and all justifiable demands were immediately met without difficulty.

The chancellor expressed his inability to understand why the Socialists took such a bellicose attitude toward Russia in this manner, and said: "Particularly in the Socialist camp a lively longing for the 'matted flat' is manifested."

Von Buelow thought a belligerent state can scarcely avoid treating neutrals as the Russian squadron had treated the Sargus.

Turning to a trial at Kronenberg of persons charged with smuggling into Russia literature of a nature which gave offense to the government of that country, the chancellor said the Prussian minister of justice would give a detailed account of the proceedings, but he would remark that the mistakes committed at that trial rested upon different opinions in judicial theory between Russia and Germany. The fact remained clearly proved that the Socialists were deliberately trying to discredit their views in Russia for the overthrow of the government.

Discussing the anti-German feeling in Great Britain, Count von Buelow reiterated that the purpose of the German navy extension was purely defensive.

"I can not conceive," he continued, "that the thought of an Anglo-German war is seriously entertained by the reasonable people of both countries."

The emperor, Count von Buelow added, had approved the plan of ruling German Southwest Africa through a civil governor.

Returning to the subject of military expenditure, Count von Buelow denied that Germany was spending relatively more than any other great nation. "A country that spends \$750,000,000 yearly for spirituous liquors," he said, "can spend \$300,000,000 as an insurance premium for national safety."

Turning to Southwest Africa, Chancellor von Buelow said the Herero's power of resistance had been broken. The uprising of the Witbois and other southern tribes was a new and severe blow, but the chancellor expressed confidence that Gen. von Trotha would do what was necessary in order to prevent further uprisings against German rule.

Count von Buelow denied the stories that famishing Hereros had been shot down upon coming from the desert to surrender. "As regards it as our sacred duty," the chancellor said, "to make a recurrence of such uprisings impossible for all time. I believe the natives must be prevented in future from having firearms. I also believe that native capitalists must be abolished."

Sufficient troops, the chancellor said, must be kept permanently in German Southwest Africa to crush future uprisings in the bud.

**Morrison Murder Case.**

Butte, Mont., Dec. 6.—The case of Mrs. Elizabeth Morrison, who is charged with the murder of Richard Finnegun, was given to the jury this afternoon and up to a late hour tonight no verdict had been reached. Mrs. Morrison is charged with first degree murder, conviction of which crime carries with it a death sentence.

**HAMMOND, TRAIN ROBBER.**

Contrary to Expectations He Was Not Arraigned.

Phillipsburg, Mont., Dec. 6.—Contrary to general expectations George F. Hammond, the self-confessed train robber, was not arraigned today on the charge of murder of Engineer Dan O'Neil. Washington, Dec. 6.—The war department has forwarded to Congress a draft of a bill providing for an annual appropriation of \$1,000,000 for the purpose of providing arms, ordnance stores, quartermaster stores and camp equipment for issue to the militia and for the payment of the cost of inspection of the organized militia, which are required to be made under the direction of the secretary of war.

**SALT LAKE ROAD WRECK.**

Brakeman Killed, Fireman and Engineer Seriously Hurt.

San Bernardino, Cal., Dec. 6.—There was a serious wreck on the Salt Lake railroad at a point on the desert about a hundred miles north of Daggett, at Sliding 21. A train of water tank cars

broke loose at the top of a heavy grade, rushed down the hill at a tremendous speed for about 10 miles, and crashed into a construction train. Brakeman John Bryant of the water train was killed and Engineer Henderson and Fireman Miller of the construction train were seriously injured. Several other members of the construction crew suffered minor injuries.

## Gribaldi's Son Dying.

Rome, Dec. 6.—Gen. Ricotti Gribaldi, the last surviving son of the Italian hero and his first wife, Anita, is dying from nephritis.

Ricotti Gribaldi has been identified with several heroic projects, including assisting the Greeks against the Turks during the war in 1897, plans to free Cuba, to establish Italian colonies in Argentina, to head the Macedonian revolutionists.

## BOISE MINER ARRESTED.

He is Charged With Deserting His Family.

Chicago, Dec. 6.—On charges that he deserted his wife and little son in Chicago three years ago David Mackenzie of Boise, Ida., a wealthy mine operator, was arrested in Chicago by order of Judge Dunne.
