CONGRESSIONAL.

SENATE.

Scott presented the majority report of

the Ku Klux committee, with testi-

mony, and a bill to extend the opera-

tions of the committee of May 7th,

authorizing the suspension of the

Adams corpus until the end of the

next session of Congress.

Blair presented a minority report and

both reports were ordered printed.

Cole introduced a bill directing the

postmaster general to provide at once,

by contract, or otherwise, for the trans-

portation of the California mails around

the blockaded portion of the Pacific

railroad.

HOUSE.

Among the bills introduced and re-

ferred, was a bill to refund the income

tax collected from 1865 to 1868; and one

for the purpose of the payment of the

public debt in legal tenders, according

to the stipulation of the bonds and the

decision of the supreme court.

The morning hour having expired the

bill went over; and Hale moved to

suspend the rules and adopt a resolution

to instruct the ways and means com-

mittee, whenever they shall report a

bill changing the laws on highly disre-

putable for putting in circulation on the

free list. The motion was rejected.

Mercer moved to suspend the rules

and pass the bill repealing duties on

tea and coffee. The motion was agreed

to, and the bill passed.

Poland, from the joint committee on

Southern outrages, presented the report

accompanied by half a dozen printed

copies of testimony, which he said

was about half the testimony, and

moved that forty thousand extra copies

of the testimony be printed. Back

submitted the vote of the minority

and asked that it be printed with the

report of the majority. Poland and

Hendrick objected to certain sentences

of the minority as reflecting upon the

majority, and other expressions as re-

flecting upon a majority of the house

and upon the executive, quoting the

obnoxious sentences. The speaker said

the language quoted was highly disre-

putable to the house, and such a bill

should not be allowed in debate. The motion

to suspend the rules and receive the

report was lost for want of a two-third

vote; and then a motion was made to

receive the report and print it with the

majority report. If the language was

not in violation of the rules of the house,

was agreed to without division.

EASTERN DISPATCHES.

New York, 19.—Mayor Hall appeared

in the court of the general sessions

this morning, and asked that the trial

of his case be postponed by immedi-

ately. General Barlow said it was well

known to Hall that Judge Daly's ar-

rangements didn't permit him to hear

the case to-day.

Over \$100,000 of claims for advertis-

ing, by weekly papers of this city, have

been disallowed as unauthorized.

The fire at Bethel, Connecticut, was

the largest ever in the State. The loss

was \$200,000.

There was an exciting scene at the

general sessions arising from Mayor

Hall appearing and asking for his trial

to be postponed with. The statement

of the attorney general, that the

mayor's appearance was a trick and

fraudulent device, with the deliberate

purpose of gaining credit with the peo-

ple and placing the attorney general in

a false position, was greeted with hisses

by a crowd of spectators. The attorney

general added he came to the court

to express his own, and what he be-

lieved to be the public indignation of

notes payable at maturity in coin or

bonds at the option of the government

and not of the holder.

EUROPEAN.

LONDON, 19.—The boiler of a factory

in St. Helens, Lancashire, exploded

this morning, wounding and killing

many persons.

The parliamentary whippers-in are

summoning partisans to be present at

the session to-night, when it is under-

stood the opposition will introduce a

second motion censuring the govern-

ment. It is believed the government

will be sustained.

Sir Charles Dilke addressed his con-

stituents this evening. The meeting

was crowded, and at the outset was

slightly disorderly. Ample precautions,

however, had been taken against trou-

ble. The platform was raised so high

it could not be scaled, the seats were

nailed to the floor, and the police were

on hand in force. The disorder sub-

sided, and Sir Charles made a long and

powerful speech against the effort to

suppress free discussion. He attacked

the monarchical principle because it

rendered the rich less able to under-

stand the wants of the poor. He wished

his opponents to beware, or they might

push the people too far.

ANTWERP, 19.—A number of persons

opposed to the presence of Count de

Chambord, demonstrated at his resi-

dence. There were some disturbances

and a few were arrested.

PARIS, 19.—Three generals of the late

emperor are leaders of a conspiracy to

disperse the assembly by force and take

possession of the government. In con-

sequence of this the Belgian frontier is

carefully guarded, and no one is per-

mitted to cross into France without a

passport.

There was a slight demonstration at

the house of the Duke d'Aumale on

Sunday, and some arrests were made.

It is said the affair was incited by Bo-

napartists.
