## CITY COUNCIL ENJOINED.

From Passing of Railway Franchise For Depot on Third Street.

Provo, April 21 .- The session of the city council last night was attended by all the members, with a goodly number of citizens also, who were interested in the proposed pranchise of the railroads for the Union depot. President Powelson read the summons of injunction restraining him with the rest of the councilmen from voting upon the ordinance granting the proposed franthise, and in consequence the ordinance which was to have been the special or der of the evening was not taken from

the table. The restraining order from Judge Booth is the result of a suit which was filed against the city council of Provo. by Jesse Knight as a freeholder and taxpayer of Provo, to restrain that bedy from passing an ordinance grant-ing a franchise to the Denver & Rie Grande Bailway commony to ise cer-Grande Railway company to use cer-tain streets and sidewalks for depot and sidetrack purposes.
