sold at public auction in Portland, Oregon, for the sum of \$750 and was bought by General Rufus Ingalls as the executor of the estate of the late Esther Halliday. President Lincoln at one time promised Ben to see that he should be paid, but before he could personally interest himself in the matter, the assassin's bullet ended his life. Subsequently the United States Senate reduced the claim to \$300,-000, but its passage never came to a vote. At one time the government, offered Ben Halliday \$100,000 for his demand, but he refused to accept the compromise. Last winter Senator Stewart, of Nevada, during a visit to Portland, told Mrs. Esther Halliday that if she would present the claim as her own, exclusive of all other alleged interested persons, the Senate would report a \$100,000 bill in her favor, but in the meantime she died. There is no question, however, as to the disposition of the United States Senate in this respect, and very likely an act will be passed at the next session of Congress allowing the amount Senator Stewart promised Mrs. Halliday to her children, Ben and Linda. The claim is regarded as a just one and will be adjusted, but whether Ben and Linda will live long enough to enjoy it is another matter.

## THE REAL AND UNREAL DR. FOOTE.

THE September number of the Health Monthly, edited by Dr. E. B. Foote, Sen., and Dr. E. B. Foote, Jr., states that the former intends to pay a visit to Salt Lake City next month. It is turned four years since the Doctor was here, and the cause of his coming at that time was somewhat peculiar. A good many people will perhaps remember a red-headed adventurer who came to this city and announced that he was Dr. E. B. He wrote an insulting letter to the editor of the News from a town in Texas, where he was running a business under a name other than the one he assumed white here.

Dr. Foote the elder is a cultured, genial, kind-hearted gentleman. His visit will be made this time-so the Health Monthly states, "more with a view to recuperation and change than to business considerations."

## THE GENIUS OF "LIBERALISM."

THE evening organ of the Ogden "Liberals" says:

"The men who instigated the reports causing Marshal Parsons to declare martial law in Ogden, should be known and their business interests boycotted."

This is a specimen of "Liberal" sentiment and is in accord with 'Liberal' practices. Business men, with some regard for public decency, were so scandalized at the flagrant immorality suffered to flourish unchecked by the "Liberal" city authorities, that they informed the United States' Marshal of the situation, and he promptly endeavored to enforce the law in relation to the evils complained of. The same paper wishes it to be understood that "Ogden would prefer to be called 'a tough place' by eastern people rather than to be called a Mormon town," and says: "Give us toughness Americanized," etc. Well, there is no accounting for taste. Respectable eastern people would prefer the morality, sobriety and good order of a "Mormon" town, to the toughness which the Ogden "Liberal" organ so greatly admires, no matter how much it may be "Americanized." They do not look upon "Americanized" gambling, or "Americanized" prostitution, as anything better than the Anglicized or Frenchified articles.

"Toughs" may admire "a tough place," but law-abiding, peace-loving, soher citizens will be attracted far more to a town with "Mormon" characteristics which are worldfamed, if falsehood is silenced concerning it, than to the toughest kind of "a tough place," where officers are abused for enforcing the laws, and business men are "boycotted" for desiring their enforcement.
