The Post, commenting on the situa-tion, contends that it is a matter of importance, considering Great Brit-ain's world-wide naval interests, to endeavor to secure a more definite agreement on the question of neutral-ity and the use of neutral waters by belligerents.

JAPAN IS IRRITATED.

Tokio, April 19, 5 p. m.-Although not reported directly, it is believed that the Russian Second Pacific squadron continues the occupation of Kamranh bay or some other port of Annam, where it is expected to remain until joined by the Third Russian Pacific coundry

squadron. The report that Admiral Rojestvensky is maintining a patrol and exam-ining neutral shipping off Kamranh bay increases the irritation towards France for permitting the use of that port as a base of operations. 
Rousseau Suspected of Insanity.
