## FATAL ACCIDENT IN FREIGHT YARDS

Leonard Williams Has Life Crushed Out Between Freight Cars.

C. H. CALLAND OUT ON BOND.

Discrepancies Adjusted and Prosecution May be Waived-C. II. Schnefer Convicted,

Ogden, Utah, Nov. 7 .- A fatal accident occurred in the Union depot freight yards here, shortly after 2 o'clock yesterday afternoon, when Leonard Williams, a well known young man of Ogden lost his life crushed out between two freight cars.

From eye witnesses to the sad accident it was learned that Mr. Williams, who belonged to a Union Pacific switching crew, was with the crew doing some switching near Twenty-eighth street. He went between two cars to couple them up when in some manner be was caught between the drawbe was caught between the draw-heads of the cars and terribly crushed through the hips. A conductor and brakeman from another train saw the needed and called to the train crew. The cars were separated and Mr. Williams fell to the ground. The crew and a Sumber of other gentlemen rushed to his assistance and notified the yard officer. The ambulance was soon on the seeme and the young man started for the hospital, but he died from the injuries before medical attention could \$1.000.

be given. His body was taken to Larkin & Sons morgue at the request of the family. The coroner was notified and an inquest may be held today.

Mr Williams had been in the employ of the railroad companies for about five years in the freight department, and later weighing cars for the Pullman company. He had been engaged as switch man only about three months. His fellow employes considered him a very careful, conscientious young man, who could always be depended upon, and general sorrow at his sad death is felt.

Mr. Williams was born in Orden about 25 years ago and has lived here all his life. He was the son of Mr, and Mrs. Hyrum Williams and a grandson of the late Dr. Williams, He leaves a wife and one small child.

The funeral will not likely be held until Sunday as his father resides at Rexburg, Idaho, and is not expected to arrive in Ogden before tomorrow.

His wife has been a faithful visitor to him daily at the county jall, always taking some dainties for him to eat.


