## STRENUOUS WORK TO REGISTER VOTERS

Political Outcome in Doubt and Both Parties Striving for Supremacy.

## SAD DEATH OF YOUNG MOTHER.

Mrs. Ransom Shortliff Called Hence in Her 25th Year, Leaving Three Little Children.

Ogden, November 1.—The registering of voters was carried on in Ogden with great energy all day yesterday. Every available vehicle in the city was hired by the political parties, manned with energetic workers who from early in the morning until 9 o'clock last night drove over the city, with lists of names of men and women who had failed to attend to that duty. The exact number of new voters in Ogden had not been figured up but it will go over 1,300 which is considered a good increase in the city's population.

If yesterday had been election day the politicians could not have worked harder than they did to get votes, which is an evidence that both the political parties are aware to the necessity of getting every vote available. The political situation in Ogden is very uncertain at the present time, both the Democrats and Republicans expect to be able to elect a part of their tickets.

## MRS. RANSOM SHORTLIFF

Answers Final Summons, Leaving Three Little Children.

Ogden, November 1.—The entire community sympathizes with Ransom Shortliff in the sad and untimely death of his wife, Mary Ann Shortliff, which occurred at 2:25 yesterday afternoon at the family residence, 2633 Farr's avenue, aged 24 years, 8 months and 39 days. The cause of death was sudden poisoning.

Mrs. Shortliff gave birth two weeks ago to a beautiful child, but she did not regain her health and despite careful nursing and medical attention blood poisoning set in with the sad result stated. She is survived by her husband and three little children.

Deceased was the daughter of James and Mary Lavender Burton, was born at Marriott, Weber county, Feb. 1, 1881, and has lived here all her life. She was well known in Ogden and highly esteemed, was an affectionate wife, a devoted mother, and a faithful Latter-day Saint. The time and place of funeral will be announced later.
