## THE CENTRAL AMERICAN CONTEST

THE little Central American Republic of San Salvador is now, ow ing to the sauguinary conflict being waged between it and Guatemala, an object of general interest.

It is difficult to glean from the dispatches a clear understanding of the cause of the struggle, but it appears to have been occasione i by an attempt on the part of Barrillas, President of Guatemala, to interfere with the internal affairs of San Salvador. He undertook to dictate as to who should be President of the little republic, aud, as a natural consequence, this meddlesome conduct was resented as a flagraut encroachment upon the prerogatives of the nation. Hence the war of which the telegrams have furnished a sort of desultory account.

San Salvador is of limited area, embraciug only about 7,500 square miles. It has a delightful climate, and the soil is highly productive, its fertility not being excelled by many parts of our globe. It is picturesquely broken up by rivers and mountains, numbers of the latter being volcanic, frequently active. population probably does not exceed 280,000, while that of Guatemala approaches 1,000,000. The Salvadorians have always been considered the most civilized and Industrious people of any of the Central American Republics.

It looks from this distance that if Gnatemala receives no assistance outside of itself San Balvador will bring Barrillas to his senses and to terms. General Ezeta has adopted offensive tactics and is carrying the war into the heart of the enemy's country, having been victorious from the beginning of hostilities.

It is asserted that in case Barrillas is driven to the last extremity Honduras will step forward to his rescue. In that event San Salvador would be placed at a great disadvantage, as Honduras bounds the frontier on the northeast and could throw her forces over the border and work great havor while the courageous Salvadorians are invading Guatemalan territory. Costa Rica and Nicaragua, on the other hand, are friendly disposed to the people who are fighting for their freedom, and promise to maintain a neutral attitude. Mexico announces a similar intention.

If telegraphic announcements are to be credited on the subject, unofficial aid has been tendered Barrillas by part es in this country. The offer is in the shape of 2000 sewers and other public works who less,

tried fighters who have been under

If this be correct, the tender reflects no credit upon those who make it. There is nothing of the sentiment of the true soldier behind the movement, as the struggle so far as they are concerned is not inspired by any element of patriotism. Neither love of freedom or country have any connection with the subject in their case. Should they enter the campaign to assist Guatemala they would fight against liberty and human rights, according to the best information attainable as to the origin of the strife between the two Central American Republics involved. Such a body as that referred to, raised in the United States, would simply go to Guatemala in the capacity of "hired assassins." Should they enter into the murderous contract and be annihilated in the conflict the general verdict would doubtless be that the world would be no worse off on account of such a result.

## THE WORKING MEN HAVE EYES.

The working men of this city, who, in convention assembled, adopted a ticket representative of their class, must feel highly complimented by the epithets hurled at them from the smut machine of the "Liberal" party.
