DISTRESSING ACCIDENT AT LEHI.

Wheeler Bennett, George W., living and others have just returned from a visit to the properties of the Royal Gold Mining Co. in Deer Lodge and the Hiawatha Gold Mining Co., and the first name speaks magnificence that they have a veritable bonanza. The mine is being driven by hand labor, the men tunnel from the surface to a depth of 24 feet. They were the wealth of the mighty fleet of steamships that sailed from the coast of the Pacific to the Orient. The vessel was a double decker, 1200 tons, and was lost with eight crewmen. A boat containing four men was lost with eight. Only twenty-three were saved. The survivors passed two days upon the desert island, and were rescued by a passing ship. Mr. and Mrs. Chain left Denver on October 1st, and were en route to San Francisco. Mr. Chain was one of Denver's oldest business men and a Christian gentleman of high standing. Mrs. Chain was well known as an artist. The couple were children, were apparently devoted to each other, and had spent much of the past five years in foreign travel. About a year ago they had a narrow escape from death in a runaway of *Bueno Vista* steamer, which property was owned by Mr. Chain.
