PUNISHMENT FOR DESERTION

Judge Advocate Buchan, of the Department of the Missouri, Favors More Lenient Policy.

HOMESICKNESS GREAT CAUSE

Gen. Morton Does Not Fully Concur But Favors Some Modification of Present Practice.

Washington, Oct. 21.—An evident desire is apparent in some portions of the army for a policy of more leniency in punishments for desertions than now exists, during the early period of enlistment. This is the view taken by the judge advocate of the department of the Missouri, Capt. Fred E. Buchan, Ninth cavalry, in his annual report to Brig. Gen. Charles Morton, commanding the department.

The report shows by the records of trials by court-martial in 114 cases, occurring within the first six months of enlistment that the offenses practically were the result of homesickness, or a change under new and unexpected restraints.
