OPEN DEFIANCE OFFERED FRANCE

Telegraph and Postal Employes Throw Down Gauge of Battle to Government.

THEY HAVE FORMED A UNION.

Serious Aspect of Movement is That Leaders Are in Harmony With General Federation of Labor.

Paris, May 6 .- The famous P. T. T. that is, the Postal, Telegraph & Telephone Employes' association, today threw down the gauge of battle to the government by transforming itself into a syndicate or union, under the law of 1884. This places the association on the same footing with workmen's

unions, with the right to strike, This defiance, which is nothing short of open revolt, came as a sudden and sensational sequel to Premier Clemenceau's failure today to receive a deputation of postal employes, who called to demand the redemption of promises they claim the government made when the recent strike was declard off.

the recent strike was ill, but the delega-tion pretended to believe his indisposi-tion was simulated. Their failure to be received, however, served as a pre-ter surprise and text for springing their surprise, and an hour later the transformation of the association into a national syndicate was announced and the statutes of the organization were officially filed in the

A COUP DE THEATRE.

It was what the French call a coup de theatre, but if it proves successful it would be more like a coup d'etat, as its purpose is to make the employes sters, and not the servants, of the

The rules of the organization follow strictly in the form of those of the workmen's organization. They declare their purpose to defend economic inneer purpose to detend economic in-terests and give moral and material support to members having differences with the administration. A committee is created, following the lines of trades unions, to act as intermediary in such difficulties, and members are forbid-den, under penalty of losing their memhership, to present issues principally to the administration.

AFFAIR SERIOUS.

The most serious aspect of the situa-tion is the fact that the leaders are undoubtedly hand in glove with the moving spirits of the general federation of labor, which is now universally recognized as a revolutionary organization, and which has for a long time been preparing for a general strike to destroy "capitalists."

Bishop W. F. McDowell of Chicago announced that the plan had the sanction of 33 denominations, representing 17,000,000 persons. The council has divided the country into four districts with New York, Chicago, Atlanta and Denver as permanent headquarters for the work in the various districts.

TO RUSH BALLASTING WORK. Portland, Or., May 7 .- Orders have

been issued by officials of the Chicago, Milwaukee & Puget Sound railroad to rush ballasting work on the line be-tween the Dakotas and the coast, and hundreds of freight cars are to be taken from the main line now in service and moved westward in preparation for handling the wheat crop this fall.

TO REDUCE CHILD MORTALITY.

New York, May 7 .-- In an effort to reduce child mortality in the congested streets of New York, Alderman Marx has submitted a plan to Police Com-missioner Bingham, which provides for the exclusion of vehicular traffic on certain thoroughfares between the hours of 3 and 6 p. m. The number of children killed by trucks and automo-biles has increased so rapidly recently that in several sections of the city parthat in several sections of the city par-ents have petitioned the board of al-dermen to limit traffic while the childdren are at play in the streets.

Several aldermen believe the plan to be a good one and have asked the police to test it on East Side streets.

DR. HUGH ROSS DEAD.

Seattle, Wash., May 7.-Dr. Hugh Ross, aged 64, a pioneer among medi-cal men on the Pacific coast and a former Red Cross surgeon, is dead at his home here. While in the Red Cross service in Manila during the Spanish-American war he furnished drugs and other necessities out of his own purse, expecting to be reimbursed later. When President Taft, as president of the Red Cross society, was in California he was served with a writ to recover, brought non-suited for lack of jurisdiction.

SUPPOSED BURGLARS' TUNNEL DISCOVERED

San Francisco, May 7.—The discovery yesterday of what appeared to be the starting of an underground passage-way beneath the flooring of a vacant store adjoining the building occupied by the Swiss-American bank, led to the circulation of a report that robbers had planned to tunnel under the bank vault, blow it open and secure the \$250,000 cash reserve kept there. Further investigation showed that a narrow opening had been cut in the flooring of the store and about two feet of tunnel dug, but the police do not believe that a assault on the bank vault was planned. The tunnel would have had to be extended more than 30 feet and pass through a brick wall to reach the vault. It is supposed that the burglars planned to break into a jewelry store nearby.

KEY FOUND TO GIGANTIC LOTTERY SWINDLE


