RECORD OF MEN AND DOINGS IN ASIA.

The Pacific Mail Steamer, *City of Peking*, arrived in San Francisco June 30th, bringing Shanghai news to June 23, as follows:

JAPAN.

The loss of the Messageries Maritimes mail steamer *Messager*, proves to be one of the most singular on record. The *Messager* left Hongkong on May 14th for Kobe, and after overhauling the steamer and towing her into Shanghai, immediately proceeded on her voyage to Yokohama with the mails and passengers for Japan. She was off the coast of Japan for about 400 miles to the northeast. The passengers were sitting down quietly to dinner and were discussing the events of their previous voyage in the *Andrey*, when suddenly a great crash was heard from the vessel and it trembled violently. At the same moment a seething mass proceeded from the engine room as if great quantities of water had been suddenly dashed in the fire. The captain at once ordered the engines to be stopped and the ship to be lowered. Orders were promptly given to lower the boats, the passengers at the same time being told to take their portable valuables and papers. The male passengers also left what assistance they could in getting down the boats.

The captain at once ordered the engines to be stopped and the ship to be lowered.
