

## CLEANS OUT THE WHOLE RANCH.

Everett Conway Kills C. W. Garrison and Wife.

## TRouble OVER A MILK DEAL

People Were Neighbors in Evansville, Ind.—Murderer, cornered by Police, Commits Suicide.

Evansville, Ind., May 19.—Everett Conway, aged 27, married, shot and killed C. W. Garrison and wife in this city this morning and fatally wounded Garrison's Benjamin Wallis. After being driven to desperation by the police, Conway then killed himself. The crime was committed in the lower end of the city as the church bells were ringing.

Conway and the Garrisons had not been neighbors for several months, but this morning Conway wrote a note to Garrison, saying he had cheated his father in a trade for a milk cow. Garrison showed this letter to Conway's father, who upbraided his son.

Last this morning young Conway was employed at the railroad yards going to the stable where Garrison was milking, shot him dead with a gun. Then he shot Garrison's son to death. Mrs. Garrison ran from the house, Conway emptied both barrels of his pistol, she died dead at his feet.

The murderer next set fire to the Garrison stable and then barricaded himself in his house.

When a police officer arrived, Wallis attempted to shoot him. Conway shot him in the side inflicting a fatal wound. The entire police department was called out, and the officers surrounded the house ready to break it in when he had a shot. Conway had kissed his wife good-bye, and then ran upstairs and died himself in the heart.

Conway came from a good family, originally from Kentucky. He leaves a wife and two children. Garrison was a carpenter.

The shot that struck Wallis brought him to two bystanders, Edward Dade and Adam Crawford. Both were taken to the hospital, but neither was seriously injured.

When the coroner entered the house, Conway had killed himself, his hand containing a note, which the coroner had addressed to a local newspaper.

"Well, friend renders, this will be for you; I will tell you why. This man Garrison has disgraced me, disgraced me when he was here but he runs away when he struck me, so I shall be sick. He's got the ranch under control, and he's got it for nothing. He did give him every d—n thing he's got—house, while stable, corncrib, stable, at eight o'clock, house, barn, stable, wagon and everything on the place he wants. He runs away, the whole family goes away, and I'm afraid my dad to discover my daughter run me out of the house, after me away from the corner, those two days before now. Friends, we must stand up, we can't stand up. Not one man, not one just, I am from Garrison, you know what's in those people now. He threatened to kill me, I guess the fig is up. I don't need to tell you what I am going to do, for you all in sight, or come and see for yourselves. Yours truly,
