

NATIONAL BANK CONTRIBUTIONS

Tillman Calls up Resolution for An Investigation of Them.

IT SHOULD BE RETROACTIVE.

"Bankers Will Get an Immunity Bath For Past Offenses," He Predicted.

Washington, June 18.—Senator Tillman today again called up his resolution providing for an investigation of the question of national bank contributions to political campaigns and also relative to the recent failure of the Chicago National bank.

Speaking to the resolution, Mr. Tillman said that Senator Aldrich had yielded under the resolution on the ground that the senate had recently passed a bill prohibiting the banks from making campaign contributions.

Mr. Tillman contended that such action on the part of the senate was not sufficient to prevent the banks from being the principal source of revenue for the Republican political committee.

He did not believe that the house would pass the bill prior to the election of next fall.

He insisted that the resolution should be retroactive, but confessed that he had little hope in that direction.

"The bankers will get an immunity bath for past offenses," he predicted.

Speaking of the Chicago bank failure, Mr. Tillman presented extracts from testimony of Banker Patton of Chicago, taken by the house committee on banking, to the effect that the bank was due to loans made by the bank to concerns in which the president of the bank, John E. Walsh, was interested.

He claimed that this testimony showed that the controller of the currency had known for months before the failure that the bank in effect loaned \$15,000,000 to its president.

Senator Hopkins replied that Mr. Tillman had been misled by irresponsible Chicago men and declared that the south Carolina senators' "tirade" had proved another illustration of the fact that "a little learning is a dangerous thing."

He charged the South Carolinians with a desire to injure the Chicago banks and to exploit himself.

"I say to the senator that he could not serve Wall street better," he said, "for Wall street wants to get control of the Walsh interests."

He again declared that the transactions in Chicago had been entirely straightforward and honorable.

No action was taken by the senate. When the senate committee on finance meets tomorrow Chairman Aldrich will lay before it a letter from Comptroller Ridgely regarding the Tillman resolution. In the letter the comptroller said he had no knowledge as to whether the acts of Walsh were criminal but that this subject now is being investigated.

GERMANS AND MUTUAL LIFE.

Berlin, June 18.—Maurice Untermyer of the International Policyholders' Protective association of the Mutual Life insurance company of New York, has been here several days arranging for German representation in the central committee. He found the policyholders of American companies already have made progress toward organization and suggested that they co-operate with the American association, which they agreed to do and also to elect members of the international committee. Dr. Wiegand of the Nord Deutsche Zeitung will be the German member.

The German co-operative committee consists of Dr. Wiegand, Louis Hagen of Cologne, leading lawyer of Berlin and Eugen Beck of Cologne, all large policyholders. Herr Hagen is insured for \$10,000.

Mr. Untermyer met policyholders in France, Great Britain and Holland, and arranged with them for their representation on the American committee. The representatives of the various countries will meet in Vienna the first week in July to arrange for concert of action.

An electrical parade in the evening will wind up the day's events.

The case has already been taken up with the president of the United States, who, Mr. Gompers said, promised to make an investigation, and the case will be taken up again with him in the near future, when further complaints and affidavits will be submitted charging continuance of grievances.

Mr. Gompers reported regarding the "bill of grievances" to President Roosevelt. President Pro Tem Frye and Speaker Cannon that "a number of congressmen had declared their willingness to aid labor in the enactment of its just legislation demands, but were hampered and hindered by the existing conditions, especially by the domination of the house of representatives through the speaker and the make-up of the committee, and those that are brought in to accomplish temporary purposes."

He called attention to the course pursued by the governors of Idaho and Colorado and to what he termed "the unparliamentary and brutal manner of kidnapping Moyer, Haywood and Pettibone of the Western Federation of Miners."
