

CAN NOT COME YET.

The Senators Postpone Their Trip to the Territories.

PLATT AND BILL TOO BUSY.

The Proposed Investigation as to Out-
Rottions for Side-track Tiff Off
Till Later.

New York, June 2.—It will be impossible for Senator Platt of Connecticut and Senator Bill of New York to accompany the anti-slavery delegation to the territories on June 10th. Senator of West Virginia, chairman of the committee on territories of the United States Senate, has notified all the members of the sub-committee appointed by him and the territorial authorities that the trip has been postponed, and that it is at present impossible to fix the day when the committee can proceed to the territories. If it is possible to secure the attendance of the sub-committee the visit will be made later in the year.

AN EXPLANATION.

SACRAMENTO—**OF A BANK PRESIDENT CONCERNING A FATHER.**

New York, June 2.—In regard to the closing of the Bank of California, Judge W. H. Woods, President of the Chase National bank says: "It is not true as stated that the bank was closed on our account. That statement was doubtless given out as an excuse. We are not responsible for the closure and made no telegraphic demand on them. The only connection we had with them was that of making them advances for which we received a simple collateral security from a well-known banker. Our small deposits are withdrawn from their offices, but other banks have no claims on us. We had advanced them. This has yet taken place."

THE SUNDAY CLOSING SUIT.

The Judge Refuses to Issue a Retaining Order for Next Sabbath.

INFORMATION GIVEN AS TO WHEN A FINAL DECISION MIGHT BE EXPECTED.

CHICAGO, June 2.—Just before the general court adjourned today, in the Fair, Judge Wm. H. Woods, United States Attorney, announced that, in the absence of a permanent decision, a retaining order is to be issued next Sunday. This was refused. Judge Woods, speaking for the court, said that the estimation could be given as to when a decision might be expected.

On behalf of the Fair it was argued that if this court should grant the prayer of the petition for an order delaying the gates on Sunday, the management would have to exert every effort to keep the gates open, or the order of the state would be violated.
