

# TELEGRAPHIC. SHOCKING MURDER.

A Woman Puts Her Eight Children  
and Kills Herself.

ALL DIED IN GREATEST AGONY.

Financial Bureaucrats Supposed to Have  
Seen the Cause of the  
dead.

NEW YORK, Jan. 14.—A special  
to the Tribune from Maryville, Kan.,  
says that at the astonishing event that  
has just occurred in Marion County  
came to light early this morning, when  
it was found that Mrs. Joseph Hiltz,  
about six miles east of Maryville,  
had poison her eight children and  
killed herself. Seven children were  
poisoned and the eighth is dying  
now.

Mrs. Hiltz's husband administered  
the poison to the little ones and then took  
one of his own. She was evidently  
conscious when the deed was done, and  
endeavored to walk to the home of her son,  
but fell, went to the barn, and  
was found dead during the night.  
The son who was with his mother  
was trying to save the place, and  
now positively avowed that they had  
no physician or apothecary. A physician  
was summoned for the child that still  
had signs of life, but there was  
no hope of saving it.

It is generally believed that Mrs.  
Hiltz's death was driven by  
rancorous differences and trouble. The  
son who was almost destitute when his  
mother went to Kansas City a short  
time ago, is to be treated as a criminal  
case because he was accused of having  
killed his mother. The son and his  
wife are now in jail, and the physician  
is to be tried for the killing of his  
mother.

of ours, however welcome it might be  
to others? Is it not to your Indians?"
