

# NO MERCY WILL BE SHOWN TRUSTS

Taft Administration Will Enforce  
The Sherman Anti Trust  
Law Vigorously.

SAYS ATTY.-GEN. WICKERSHAM

In Answer to Cries of "Let Us Have  
Peace," Declares Price of Peace Is  
Obedience to the Law.

New York, April 30.—The Sherman  
anti-trust law will be enforced by the  
Taft administration. Robates will be  
prevented so far as possible. The work  
of the Roosevelt regime in this direction  
will be carried forward with vigor,  
though by different methods.

Atty.-Gen. Wickersham announced  
this tonight in an address before the  
New York bar.

"You all know," said Mr. Wickersham,  
"that the attitude of a very  
large part of the business community  
towards some of the laws enacted by  
congress was, prior to six or seven  
years ago one of indifference when not  
one of hostility."

"There was a prevailing impression  
that many of the laws dealing with  
economic subjects had been passed to  
be pointed to with pride, rather than  
to be enforced. Then there came a rude  
awakening. The last administration  
set to work with vigor, with energy,  
and was accompanied at times with  
newspaper clamor, to enforce these  
laws. Business men who eight years  
ago had not read the Sherman anti-trust  
law today know it by heart; and  
railroad men and shippers, alike have  
acquired personal acquaintance with the  
interstate commerce act."

"The work of the present administration  
is none the less important, than  
was that of the last in continuing to  
enforce the laws and in endeavoring to  
effectuate the intent of the people, in  
preventing the things which the people  
have come to believe to be inconsistent  
with the welfare of the republic;  
but the methods which are necessary  
to awaken the business community  
to a recognition of the existence  
and vitality of these laws are no longer  
residual."

It probably is true that in the movement  
to impress upon the whole business  
world the meaning and force of  
certain laws some suits were instituted  
without an adequate cause.

"When such conditions are found to  
exist the present administration is  
willing to institute suits, but it
