The deceased was a native of Bolton, Manchester, England; embraced the gospel in the God. His funeral was largely attended. He fore. Shipments to San Pedro every ten days. leaves a large family to mourn his loss.-Com. [Mil. Star please copy.

In Fillmore City, Sep. 24th, 1867, Elder WIL-LIAM FELSHAW, aged 67 years, 7 months and 21 days.

Deceased was born in Granville, Washington County, New York, February 3d, 1800. He was baptized into the Church of Jesus Christ of Latter-day Saints, May 20th, 1832, in the town of Spafford, Onondaga Co., N. Y., by Elder Orson Hyde; removed to Kirtland, Ohio, arriving there on the 1st of June, 1835; labored on the Temple at Kirtland as one of the chief carpenters until its completion; was ordained to the Lesser Priesthood in 1836, and shortly after was ordained an Elder and subsequently was ordained into the High Hriest's Quorum. Removed to Caldwell County, Mo., in 1838; passed through the varied and trying persecutions incident to the Saints in that mobocratic State; gathered with the Saints to Nauvoo; labored long and diligently ou the Temple there, being one of the three foremen appointed to do the woodwork; and was one of the number who covenanted, when the Twelve left Nauvoo, to lebor until the lower room of the Temple should be finished, even should they have to live on bread and water; left Nauvoo, May, 1846, moving up to Winter Quarters where he remained till the spring of 1848, when he moved to Gallands' Grove. In 1851 he gathered with his family to G. S. L. City, whence he was sent to Fillmore in the spring of 1852, to superintend the building of the State House. In the spring of 1857 he was called on a mission to the States which he filled (crossing the plains with a hand cart) and returned home the year following. During the time of his residence in Fillmore he was President of the High Priest's Quorum. He had also the honor of representing his fellow-citizens of Millard County in the Territorial Legislature Most Complete for two sessions. He was for several years Probate Judge of Millard County, and Mayor of Fillmore City. In all the vicissitudes of life, and in all the stations he was called to occupy, he was ever true and faithful to the Kingdom of God, and though he is now gone from our midst he will long be remembered as an unflinching advocate for the truth as revealed in the latter days, and it may be said of him: "Blessed are the dead who die in the Lord from henceforth; yea saith the Spirit that they may rest from their labors and their works do follow them."-Com.



S. L. City. In the fall of 1862 he moved to Wellsville, Cache Valley, where he till his death lived with his youngest daughter. He lived and died a Saint, was true to his covenants and his God, and departed in full faith of s&wlm a glorious and happy resurrection.-Com.
