When the city council meets tonight the slaughterhouse ordinance in regard to meat inspection will be presented for the first time.

It was first proposed to have government inspection, but many of the small butchers object, saying that the expense would put them out of business.

The measure makes the violation of any section of the ordinance a misdemeanor punishable by a fine of not less than \$10 or more than \$200.
