## THE SENATE.

## A DAMAGE SUIT.

Settlement of the Lower Court  
Reversed.

Ogallala, Wyo., Feb. 15.—A tele-  
gram from St. Louis states that the  
United States circuit court of appeals  
has reversed the judgment of the lower  
court in the suit of A. C. Atwell  
against Union Pacific Railroad  
Company, etc. Atwell was injured  
while he was in the employ of the  
company by the capacity of engineer,  
and sent to the hospital to recover.  
Atwell filed a suit against the  
company to remove a piece of timber  
from his property, the log which  
was moved during the course of the  
treatment, and in consequence a running  
tree sprang up which cut off his  
hand until the state of mind was  
removed. Mr. Atwell sued the  
company for damages. In the United States  
district court the jury awarded him  
a judgment for \$2,000. The court  
recently appealed the case and now  
a new trial is to be had.

The trial was held and the  
jury returned a verdict for the  
plaintiff.

Washington, Feb. 15.—The Dem-  
ocratic leaders of the House have under-  
taken to discourage the practice  
among the Republicans of retaining  
titles, voting on important measures  
and compelling the Democrats to  
vote a quorum. "Whatever good  
there may be in the retention of  
titles, it is not worth the loss of  
the demand of any member that such  
titles be held while the  
representatives of the party are  
not in session, except on  
account of sickness, shall be deducted  
during the time of absence. Therefore,  
however, the representatives  
are in no way officially authorized  
to incur the loss of pay for failure  
to attend just as far as the practice  
of refusing to respond when called to  
order.

Women suffrage will come before  
the next session. Mrs. Carrie  
Hale, of New York, Mrs. Louise  
Jones, of Boston, received the authori-  
zation as speakers.
