WATER CROWNS.

The committee on water-crowns recommended that the city of Salt Lake be asked to let a crew of men lay water-crowns on the streets with all reasonable haste so as not to interfere with street paving next spring. Adopted.

EXHIBITION OF PLANS.

The committee on plans reported as follows on the matter of the application of the slate Lake City Railway company and the printing of the property owners on the same:

First—As to the West Temple and Hope street line, we recommend that the railway company be allowed to continue to operate the line on West Temple street for one-third the distance between Ninth South and Hope street, promptly, and that the company be given the right to extend the line across the street on each side, as circumstances agreed.

We recommend that an extension of six miles be given to the line from the point where the line now terminates, which will be in order to counteract the effects of the odor so peculiar to sewer-mane.

Second—As to the Capitol, all time we recommend that the company be requested to accept a franchise along Court street, from Congress street, to the Capitol grounds, in lieu of the present one, which extends from First Street to the Capitol grounds.

Third—As to the Second East and Hope street line, we recommend that no action be taken at this time.

We recommend that the papers be referred to the city attorney to prepare the necessary resolutions covering our two franchises.

STREET SCRATCHING LINE DOWN.

After thirty minutes' discussion it was decided to "lay off" about one-third of the sprinkling wagons for the season.

THE PARK COMMISSION MEETING.

Mr. Lawrence, president, an application providing for the erection of a public building for the use of the city commission was called up.

Hardy moved to refer it to the city commission as a board of revision on ordinances.

Moran moved to amend the ordinance setting for one month. Carried.

The ordinance was read the first time after which it was laid on the table until the next meeting.
